- 5. Client agrees to provide Guelph Museums, at no charge, one copy of any and all publications in any fixed media which uses images of any and all images requested.
- 6. Client agrees to provide labels that accompany the image giving credit to Guelph Museums. The credit line shall read "**Courtesy of Guelph Museums**". The ID# of the image should also accompany the image but may be in much smaller print.
- 7. It is the Client's responsibility to ensure that its use of the photographs raises no legal claims. Guelph Museums will not be responsible for any damages or claims arising from the unauthorized use of the image.
- 8. Client agrees to save, keep harmless and indemnify, jointly and severally, Guelph Museums, its officers, employees, representatives and agents from and against any and all claims, expenses, demands, actions, causes of action and for any and all liability howsoever caused and by whomever caused, arising out of, but not limited to, the Client's use of the image including but not limited to any publication or reproduction.
