## GROUP LEADERS REPORT FOR 1978.

On the 13th September 1978 we celebrated our Silver Jubilee with a Thanks Giving Mass, Going Up Ceremony and a brief history of the 2nd Ringwood (Our Lady's) Scout Group over the past 25 Years. A fortnight later the Group, Scouters Families, Parents and District Cub Leader (Marie Austin) travelled by bus to Walhalla as part of our Silver Jubilee celebrations. It was enjoyable to see Cubs and Scouts away together in a happy atmosphere. This outing was the high light of the year.

Last year I made mention on several occasions that for the Group to be successful everyone (Cubs, Scouts, Venturers, Leaders, Parents and Friends) must do his or her best to sell 2nd Ringwood Scouting. Our goals were achieved in as much as 3 new Leaders joined our ranks at various stages throughout the year, the waiting list for boys to join the Cub Pack increased by 24 for 1979, two Scouts were recruited from other Districts and two intakes of Cubs (9 boys) to h the Scout Troop. The Venturer Unit commenced with 6 Scouts from the Troop on 14/3/79 and it is anticipated before 1980 girls will join our Venturer Unit. One Scout before Going Up to Venturers (Ewan McGilp) obtained the 1st Adventurer Cord (in this Group) the highest award in Scouts. Ewan along with the other Venturers in two years time I hope will have earnt the Queens Scout award the top Venturer award.

Present strength in the various sections are as follows:-

Boys Cubs 18, Scouts 20, Venturers 6. Leaders "4, "4, "1.

However 2 Assistant Cub Leaders depart us this month, Cathy Schultz to Croydon District and David Probert and family to Sydney. I wish them every success in the future. One Assistant Scout Leader is also away until mid June. These Leaders need to be replaced quickly as Arch Lavell (Cub Leader) will be on his own with 24 boys at various stages throughout the comming year while Assistant Cub Leader (Trevor Molloy) is away on business.

Leader requirements:- Male/Female 15 to 50 yrs., will be trained by the Scout Association to the required standard, have a free night per week to attend the section.

This leads me to our next goal to be achieved in 1979, a second Cub Pack. It has been talked about for a long time but unless it commences this year with three new Leaders we will be taking a backward step. YOU THE PARENTS HOLD THE KEY TO SUCCESS talk about Scouting where ever you go "Success breeds success".

The present Cub Pack will not have vacancies for more than 10 boys in 1979 and 6 in 1980. At the moment 36 boys are on the waiting list for Cubs. This effectively means by mid 1979, 20 boys have no chance of entry into Cubs until 1981, 82. The Group needs Leaders.

At this stage I would like to thank the Parents Committee as a whole and to those Parents retiring this year a job well done, I thank you one and all. I wish to express my gratitude to the Scouters for their support and assistance throughout the year. Finally a thank you to the Scouters Wives and Families for their understanding and support.

Sunday 11th February may be of little signifiance to some people but at 3.40a.m. I was awakened by a phone call to say the Scout Hall had been destroyed by fire. This disaster has caused much discussion and tonight you will hear the Subcommittee's report on suggestions and information on aquiring a new Hall.
