- 5) Secretary, Municipal Association of Victoria bringing to the attention of the Council a summary of the provisions in the State Budget introduced into Parliament by the Premier and Treasurer, the Hon.H.E.Bolte, M.P. on the 26th September, last. The following matters are included:-
  - (a) The Municipalities Assistance Fund has been increased by £50,000 to £200,000. The current basis grant for recreation reserves, children's playgrounds and similar amenities will be increased from £800 to £1,000, and where a shire has to provide recreational facilities to a large number of centres, the Government proposes to increase the maximum subsidy to £1,500.
  - (b) The subsidy towards the salary of infant welfare sisters will be increased from £600 to £750.
  - (c) The amount to be paid to municipalities towards the cost of immunisation campaigns will be doubled. The new rate of payment will be 10d. per injection.
  - (d) In the case of home help schemes, the Government will continue its assistance at the rate of 4/5th of the net cost to municipalities but for subsidy purposes, the wage ceiling for full time housekeepers will be increased from £10 to £12 per week.
  - (e) An amount of £334,000 has been provided for free library services throughout the State. This includes £20,000 for regional library centres.
  - (f) The maximum subsidy for a swimming pool will be increased from £6,000 to £7,500.

- 1. Grading has been carried out in the following streets:
  Allens Road, Armstrong Road, Montalbo Road, The Greenway, City Road,
  and Ireland Street.
- 2. It is anticipated the intermediate course of road pavement in Mullum Road will be stabilized early next week.
- 3. Construction work in the Royal Avenue and group continues to move smoothly. Kerb and Channel has been laid in Coleman Street and approximately 50% of Royal Avenue and 30% of Stoda Street.
- 4. Construction of concrete kerb and channel in the Highton/Morinda Street group is complete and placing of road paving material in preparation for stabilization is well advanced.
- 5. Construction of concrete kerb and channel in Alexandra Road between Wood Street and Dublin Road has commenced.
- 6. Work has recommenced on the channelization of the intersection of Wonga Road with Warrandyte Road where earthwork is nearing completion.
- 7. East side of road widening in Warrandyte Road between Wonga Road and Dickson Crescent has been primed.
- 8. Tip for the disposal of inorganic incombustible refuse at lot 5, Quamby Road, off Old Warrandyte Road, North Ringwood, opened on 2nd October, and is to be open 7 days a week from 8 a.m. to 5 p.m. Because of the limited depth of the tip, car bodies are not acceptable.
- 9. Easement drains in Robinson Street and Woodside Avenue have been completed.
