# HEALTH INSPECTOR'S REPORT

I have the honour to submit the following report: -

SEPTIC TANKS: During the period of this report 42 permits were issued, granting permission to install septic systems. 19 Septic tanks were inspected at varying stages of construction. Seven complaints were received alleging nuisances arising from the installation of septic tank systems. Two notices were served on ratepayers, calling on them to abate nuisances. All complaints were investigated.

QUAMBY ROAD TIP: The tip is conducted in a satisfactory manner. Dumped rubbish has been consolidated, a working face formed and the whole area generally tidied and levelled.

RINGWOOD MARKET: This market operates under orderly and sanitary conditions.

RINGWOOD DAIRIES: I have inspected both Dairies for the bulk handling of milk. They are operated and maintained in a hygienic manner.

FOOD PREMISES: During the period of this report 10 samples of various foodstuffs were selected at random and submitted to the Council's Analyst for chemical analysis. Approximately 20 lbs. of meat was declared to be unfit for human consumption. One case of fish was examined and found to be unfit for consumption. A total of 22 inspections of food premises were made, six notices were served on the owners of food premises, calling on them to maintain their premises in a clean and sanitary condition. A detailed report was submitted to the Council on the unsanitary condition prevailing at a Cafe and Butcher shop.

INOCULATIONS: Under the supervision of Dr. William Hewitt, Medical Officer of Health, 467 Triple Antigen, 309 Poliomyelitis, and 164 Smallpox inoculations were made.

INFECTIOUS DISEASES: 2 cases of Rubella, 4 cases of Infantile Diarrhoea and 1 case of Chronic Brucellosis were reported.

DRAINAGE COMPLAINTS: 13 complaints were reported and all were investigated. Three cases were referred to the City Engineer. Advice was given on the remaining cases.

FACTORY INSPECTIONS: Total 12. One notice was served on the owner of a factory, calling on him to abate a nuisance arising from the discharge of industrial effluents to the street frontage.

REGISTRATIONS: Under the powers conferred by the Health Act, persons are required to register any building, room or rooms within a building or any suite of rooms, being a portion of a building, if they intend to use them as a Boarding House or as an Apartment House. Persons intending to add or to alter a building for the purpose of running an Apartment or Boarding House, are advised to make an application to the Senior Health Inspector, before effecting alterations to an existing property.
