suburban stations is one for Railway management and it is understood that it is not the Commissioners' intention to replace staff at those suburban stations, which, although extremely busy during peak periods, are almost deserted after 9 p.m. The cost of wages for a man to remain in attendance at such stations often exceeds the income from passengers even if the whole of their fares are credited against his employment cost, and the cost of carrying the passenger is ignored. The Council's representations will be brought to the notice of the Railways Commissioners.

Guardians are not provided at stopping places by other public transport organisations, and for some years several suburban stations have been unmanned after the evening peak period.

I have the honour to submit the following report: -

SEPTIC TANKS: During the period of this report 12 permits were issued, granting permission to install septic systems.

10 Septic systems were inspected at varying stages of construction.

QUAMBY ROAD AND BELL BIRD PARK GARBAGE TIPS: Both tips are in an orderly condition.

RINGWOOD MARKET: I have inspected all stalls in the area. All owners have eo-operated in helping to maintain the area in a clean and sanitary manner.

RINGWOOD BULK

HANDLING DAIRIES: Both Dairies have been inspected, they are operated and maintained in a proper manner.

FOOD PREMISES: A total of 12 inspections of food premises were made.

Two notices under the provisions of the 1956 Health Act were served on the owners, calling on them to maintain their premises in a clean and sanitary condition.

A regrettable feature of many food premises is the disreputable condition of yards to the rear of the premises due to accumulation of trade waste and miscellaneous refuse.

A detailed report has been submitted regarding the earriage and transport of meat in a private vehicle.

FACTORY INSPECTIONS: Total 3. One notice has been issued, calling on the owner of a factory to provide reasonable and proper toilet facilities for the use of his staff.

Another request was made to tidy a factory area and to remove all rubbish and debris.

DRAINAGE COMPLAINTS: Total 4. All complaints were investigated and advice offered. One drainage matter was referred to City Engineer's Department.

INFECTIOUS DISEASES: One case of Pulmonary Tuberculosis, 2 cases of Diarrhoea in infants under 2 years of age, and one case of Scarlet Fever were reported.
