Secretary, Melbourne and Metropolitan Board of Works - advising that in the modifications to its Interim Development Order which were incorporated in such Order when it was again approved by the Governor-in-Council on 3rd April last, the Board included a provision - Clause 23 - designed to control the erection and use of advertisements by including the following paragraph -

- "5. Save with the consent of the responsible authority no Advertising Hoarding or Advertising Sky Sign may be constructed on any part of any land (not being land within the Central Business Zone) within -
 - (a) 200 ft. of land reserved for the purpose of a main road,
 - (b) 100 ft. of the boundary of a Residential "A", Residential "B", Residential "C", Residential "D" or Reserved Living Zone."

In drafting Clause 23 it was the Board's intention to reduce the restrictions imposed to those which were considered imperative both to preserve the amenity of the zones dealt with, and to ensure the efficiency of highways. The Board considers it should have control over advertising hoardings and advertising sky signs not only within 200 feet of reserved main roads but

also of metropolitan main highways, and as a result, the Board resolved to request the Governor-in-Council to amend its Interim Development Order by the inclusion of the following words at the end of Paragraph (a) of sub-clause (5) of Clause 23 "or of any metropolitan bridge or of any metropolitan main highway within the meaning of Part VI of the Melbourne and Metropolitan Board of Works Act 1958." The Interim Development Order, as amended, was approved by the Governor-in-Council on 6th June, last.
