The footpath and/or channel in the street, which is about to be constructed, will be of concrete, and if you desire a vehicular crossing to be made, will you please sign and return this Agreement, addressed to the City Engineer, Ringwood, otherwise a crossing opening will NOT be provided.

If the work is carried out while the concreting plant is angaged in the street, and at the same time as the footpath and/or channels are being constructed, a crossing 9 feet wide can be constructed at an estimated cost of \$60.00. each This cost will be added to your street liability and may, if you so desire, be repaid in the same way PROVIDING this form is returned within the next 14 days. (See Note 1 at the foot of your First Schedule notice.)

If the work were carried out at a later date it would be necessary, in addition to constructing the concrete crossing, to remove the 3" thickness of concrete in the footpath and replace with the required thickness, and remove a number of bays of kerb and channel and replace with a crossing opening.
