HIGH SCHOOL ADVISORY COUNCILS ARE FORMED AS FOLLOWS

- (a) 5 members elected by parents.
- (b) 5 members nominated by District Inspector and Head Master to represent various district interests.
- (c) 1 representative nominated by each municipal council in the school district.
- (d) District Inspector.
- (e) Head Master.

Nominations for the five elected members in group (a) can only be made by parents or guardians of pupils attending the school, must be made on prescribed pink forms (obtainable from the school), and must be in the hands of the Head Master 7 days before the meeting.

Persons nominated for positions on the Advisory Council need not be parents or guardians.

The Advisory Council is elected for a period of 3 years commencing 1st July next.

Each family should make a special effort to be represented at this meeting.
