**ENDORSEMENT FORM**

V.M.F.L. players intending to interchange with V.F.L. Senior, Reserve or Under 19 Clubs shall first lodge with the Secretary of their Controlling Body a Form 3 (a) which must be signed by the applicant player. Such application shall be completed by the Secretary of the Controlling Body concerned and returned by him to the Secretary of the V.F.L. within ten days of its actual date of lodgement with the Controlling Body concerned. If for any reason whatever the Form is not returned in the specified time, it shall be within the power of the V.F.L. to grant the applicant permission to play without the production of the Form.

After the 1st July in each year, a permit for a player from V.M.F.L. Club which has not completed competition matches for the current Season shall be granted only on production of a letter from the player's V.M.F.L. Club indicating that the Club has no objection to the transfer. Completed Form 3 (a) is to accompany the Club permission. Permits for players from V.M.F.L. Clubs which have completed competition matches for the current Season to be transferred in the usual way, i.e. by use of Form 3 (a).

Form 3 (a) shall be used as an interchange Form only, permitting a V.M.F.L. player to play with his V.F.L. Club and his V.M.F.L. Club when his services are not required by his V.F.L. Senior, Reserve or Under 19 Club.

If for any reason whatever the Form is not returned in the specified time, it shall be within the power of the V.M.F.L. Controlling Body to grant the applicant permission to play without the production of the Form.

V.F.L. players — Senior, Reserve or Under 19 — when granted permission to play with V.M.F.L. Clubs are subject to V.M.F.L. Permit Rules. (e.g., a player of a Diamond Valley League Club who is granted a permit to play with the Carlton Club — Senior, Reserve or Under 19 — cannot be granted permission by the Carlton Club to play with a Metropolitan League Club. Such player is required to obtain a clearance from his former V.M.F.L. Club and Controlling Body, excepting where a period of three years has elapsed since the player last played with a V.M.F.L. Club, in which case he is permitted to transfer to any V.M.F.L. Club without a clearance from his former V.M.F.L. Club).

A senior player granted permission to play with a V.M.F.L. Club may be recalled by his V.F.L. Club at any time.

AMENDMENTS TO THE STATEMENT OF PURPOSES AND RULES  
AND CLUB AND PLAYER TRANSFER RULES BOOKLET (1986 EDITION)

1. Amendment to Rule 1(K) - March 1986

'An affiliated League/Association or club of the VMFL shall not be entitled to receive nor request a transfer fee or monetary gain from another VMFL League/Association or club and any document by a League/Association or club requesting such a fee or monetary gain shall be regarded as material evidence at any hearing on a player refused a clearance.'

2. Amendment to Rule 7(a) - May 1986

'A club refused permission by its affiliated body to transfer in its entirety to another affiliated body within the VMFL, or transfer a team or teams to another affiliated body within the VMFL, may appeal to the Investigation Committee of the VMFL within the period 1st September - 31st October.'

Amendment to Rule 7(f) - May 1986

'If for any reason a clearance application by a club to transfer in its entirety to another affiliated body or transfer a team or teams to another affiliated body, is not heard and completed by an affiliated body within 21 clear days from the date of its despatch by the club, it shall be within the power of the VMFL to grant a clearance of the club or team or teams.'

3. Amendment to Rule 8(g) - May 1986 - October 1986

'A deposit of \$100 must be lodged with an appeal together with the players refused clearance application. Such deposit may be forfeited should the appeal be considered frivolous.'

The defendant club must also lodge a deposit of \$100 at least 48 hours prior to the hearing which may be forfeited should the appeal be considered frivolous or should the club not be represented at the hearing.

Should any club fail to lodge such deposit it will be within the power of the VMFL to grant a clearance to the player concerned.

Both the defendent and appellat clubs must also lodge an administrative fee of \$20 refundable only if the appeal is withdrawn.

5. Amendment to Rule 8(c) - October 1986

'Any player appealing to the VMFL Player Appeals Board must be free of all registration encumbrances of that body to which the player is transferring.'

7. Amendment to Rule 42 - October 1986

'A panel of 9 persons from which to select an Independent Tribunal consisting of any three members shall be elected at each annual general meeting. Such persons shall not be ordinary members of the VMFL. The Tribunal shall deal with players, officials and all the bodies charged with misdemeanours arising from games arranged by the VMFL. All decisions of the Tribunal shall be final.'


