The closing date for all appeals shall be 1st July in each year, excepting that a player whose second or latest application for a clearance is refused after 1st July, shall be entitled to appeal to the Players' Appeals Board in accordance with the provisions of the Constitution, provided such clearance was lodged prior to 1st July. Determination of the commencement of a clearance shall be the date of lodgement with an affiliated body on or prior to 1st July in each year. A deposit of \$50.00 must be lodged with an appeal together with the player's refused clearance applications, such deposit may be forfeited should the appeal be considered frivolous. The defendant club must also lodge a deposit of \$50.00 which may be forfeited should the defence be considered frivolous or should the club not be represented at the hearing or should the club fail to advise at least 24 hours prior to the scheduled time for the hearing that it will not be represented at the hearing. Any club which fails to lodge such deposit shall not be entitled to representation at any hearing of an appeal. The decision of the Appeals Board shall be final.

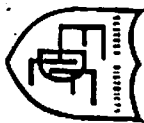

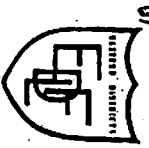

APPEAL RIGHTS OF V.M.F.L. PLAYERS

A player of a club of an affiliated body who has had two or more clearance applications to transfer to another affiliated body refused within one season may appeal on the approved form to the Players' Appeals Board of the VMFL against the second or latest refusal within seven days of such refused clearance being received by the affiliated body to which the player wishes to transfer.

The appeal shall be heard whenever possible, within 14 days of receipt by the VMFL Secretary of written notice of such appeal.

The clubs and players concerned shall each be entitled to representation at the hearing, the number of persons having representation to be limited to the player and his advocate who shall also be the club's representative and the defendant club's representative and its advocate. Such representatives shall not be qualified to act as a barrister or solicitor.

The closing date for all appeals shall be 1st July in each year, excepting that a player whose second or latest application for a clearance is refused after 1st July, shall be entitled to appeal to the Players' Appeals Board in accordance with the provisions of the Constitution, provided such clearance was lodged prior to 1st July. Determination of the commencement of a clearance shall be the date of lodgement with an affiliated body on or prior to 1st July in each year.

A deposit of \$50.00 must be lodged with an appeal together with the player's refused clearance applications, such deposit may be forfeited should the appeal be considered frivolous. The defendant club must also lodge a deposit of \$50.00 which may be forfeited should the defence be considered frivolous or represented at the hearing. Any club which fails to lodge such deposit shall not be entitled to representation at any hearing of an appeal.

The decision of the Appeals Board shall be final.

FOR V.F.L. PLAYERS ONLY

Permit Rules (e.g., a player of a Diamond Valley League Club who is granted a permit to play with the Carlton Club — Senior, Reserve or Under 19 — cannot be granted permission by the Carlton Club to play with a Metropolitan League Club. Such player is required to obtain a clearance from his former V.M.F.L. Club and Controlling Body, excepting where a period of three years has elapsed since the player last played with a V.M.F.L. Club, in which case he is permitted to transfer to any V.M.F.L. Club without a clearance from his former V.M.F.L. Club).
