FUTURE

Our candidate will seek the co-operation of his fellow Councillors to implement the following:----

- 1. AN EXPANDED PROGRAMME of private street construction.
- 2. VALUE IN RETURN FOR RATES.—To give the ratepayers value in the way of services for which they pay and do not receive.
- 3. **TECHNICAL SCHOOL.**—To make representation to the proper authority for the erection of a Technical School in Ringwood. At present boys who wish to pursue a technical education have to travel by train to Ferntree Gully.

- 4. GREATER MELBOURNE SCHEME.—To press for adequate compensation for land acquired or adversely affected under the Master Plan.
- 5. **HIGH COST OF ELECTRICITY.**—To urge the State Electricity Commission to lower the cost of electricity to conform to charges made in the inner suburbs.
- 6. HOSPITAL.—Under the Master Plan land has been set aside in Ringwood for the erection at some future date of a hospital. Ringwood is in great need of a hospital to cater for the needs of the citizens and our candidate will press for the establishment of same.
- 7. HEATHERDALE STATION.—Early construction of station already approved by Railway Commissioners.
- 8. STREET LIGHTING.—To press for more street lights in the streets of the North Ward, some of which remind one of the Black Hole of Calcutta.
- 9. BETTER FACILITIES FOR TRAIN TRAVELLERS. —In view of the large volume of travelling public using the Ringwood Station, improved facilities are more than urgently needed.
- 10. DANGEROUS CROSSINGS.—To construct "zebra" crossings at strategic places on main roads or where children cross over on the way to schools.
