The matter was then placed before the Society's Solicitors
Messrs Hodgson & Finlayson, who stated that without further
and mature consideration they were not prepared to give an
opinion, but would be quite satisfied that the Society's position
would be safeguarded if the Southern Victoria Pear Packing Co:
would give the Society a letter relieving the Society of any
markery liability in this regard. A request was made verbably
to the Southern Victoria Pear Packing Co: for such a letter,
which the Managing Director, Mr. F.rank Moore, refused to give
without authority from his Company's Insurers.

A Conference was then held at the Australian Mutual Fire Insurance Society's Offices between the Manager of the Australian Mutual Fire Insurance Society, the Manager of the Northern Assurance Co:, the Managing Director of the Southern Victoria Pear Packing Co:, and your Secretary. The Manager of the Northern Assurance Co: as Insurers for the Southern Victoria Pear Packing Co: was not prepared to relieve this Societyman of liability pointing out that it was something he could not do

but gave his opinion, verbably, that no claims could be made except in the case of wilful negligence by a servant of the Society. He offered to give the Society a Certificate of Currency as to Insurances covering Pool Fruit to which Mr. Moore objected as he felt that by asking for such a document it was casting a doubt on his assurances in his letter of the 17th March 1945, but he was prepared to forward a further letter giving an up-to-date list of Pool Growers and their spaces in the Ringwood Cool Store, whose fruit was covered by his Company, neither of these documents had been received
