- 3. The President or Vice-President shall, within fourteen days after receipt of a written requisition signed by ten governors or subscribers, setting forth the object for which the meeting is to be convened, convene a special meeting of the governors.
- 4. Every such special meeting shall be convened within one calendar month, not less than fourteen days from the date of the notice thereof or the receipt by the President or Vice-President of such requisition, and in the event of the President or Vice-President refusing or neglecting to convene a special meeting within the time prescribed, the requisitionists shall have power to covene such meeting.
- 5. The governors shall have power to adjourn any of their meetings, general or special, from time to time.

CHAPTER IX.—OF PRIZES.

A sum of money, to be voted for that purpose by the Council, shall be expended each year in the purchase of prizes.
