Business: - To receive Report and Balance Sheet for the
year 1882, and to elect members of Council

Minutes of last Annual Meeting held 24th January 1882 were
read and confirmed on the motion of C^r. Caselli, seconded
by Dr. Mann. The Acting Registrar read the

Statement of Receipts and Expenditure for 1882, the General
Balance Sheet to 31st Dec^r 1882, the Auditor's Report certifying
the Accounts to be true and correct in every particular, and the
Annual Report of the School

C^r. Bickett moved that the reports and Balance Sheet be received
C^r. Caselli seconded. - Carried.

C^r. Mann moved that the same be adopted, and Mr. J. J. Jones
seconded, Carried.

The Vice-President submitted the names of the members to
retire by effluxion of time viz: - The Mayor of the City of Ballarat,
The Mayor of the Town of Ballarat East, The Honorable James
Campbell, J.P., M.L.C., H.R. Caselli, J.P., and Theo. Mann, B.B.;
and stated that C^r. Theo. Williams had been appointed by the
Council to fill an interim vacancy caused by the resignation of
Dr. Heber; also, that there was a vacancy for one additional member
to complete the number allotted by the Constitution.

The retiring members above named including Mr. Theo. Williams
who was nominated by C^r. Mann were unanimously re-elected
members of the Council, and Mr. J. J. Jones was elected to fill
the vacant seat on the Council.

A Council meeting was then held there being present
