Staff were received.

The report of the Mining Laboratory Committee was read
by the Chairman and adopted. - The question of purchasing
a small steam engine and a dynamo as suggested in a
memorandum received from Mr Dawson was referred back to
the Mining Laboratory Committee for further inquiry and report.
The correspondence from the Education Department, re
superintendence of examinations, and intimating that the
Regulations do not provide for grants to museums and libraries,
or for treatment of ores for the public, was submitted. - It was
resolved to make a further effort to obtain the desired alteration
of the time fixed for the examination in Freehand Drawing.

The question of appointing examiners for Plumbers Certificates
was left in the hands of the two Vice-presidents and Mr Figgis.
