
(WILLIAM) HENRY KIRWAN of MARYSVILLE

(William) Henry and Bridget Kirwan nee Cussens were amongst the earliest settlers in Marysville owning and operating the Junction Hotel, one of the four hotels in the town that became unlicensed in the late 1800s and known as The Temperance Hotel. Their sons were involved in gold mining amongst other things and their daughter married William Edward Chester, who found, part-owned and operated the Golden Secret Mine at the Cumberland River.

Also in the area was Henry's brother John Kirwan who moved to Alexandra in 1869 where he held the licence for the Shamrock Hotel. The two families were close. Disaster struck when the Hotel burnt down in 1883 and John's mother in law and his wife both died in 1884. John was struggling and became insolvent in May 1885. They moved to Carlton. Their story appears in this document.

(William) Henry Kirwan was the fourth son of John Kirwan and Jane Brookman who married in Ireland. Several of their sons came to Victoria in the late 1850s. This document starts with William Henry who settled in Marysville. The other siblings and their families follow.

4. **William Henry Kirwan** (c1836, Co Galway, Ireland – 1899, Ararat Asylum. Vic). In 1861 at St Marys, Inglewood he married **Bridget Mary Cussen** (c1844 Co Limerick, Ireland – 1921, Fairfield at home of her daughter, Belinda). Bridget was the daughter of James Cussen and Catherine nee Dooley. Honoria Kirwan, wife of William's brother John, was one of the witnesses to their marriage.

Martin Cussen, Bridget's brother was in Marysville prior to the Land Sales of December 1864 with a 7 roomed wooden house with shingled roof and verandah which he had built on Block C Lot11 on the corner of Pack Road and Murchison Street. William Henry Kirwan, Martin's brother in law, purchased this block on 28 April 1865 and William and Bridget ran their Junction Hotel from this building.

Butlers Woods Point Directory 1866 records Wm Kairwen [sic] operating the Junction Hotel. Balliere's Directory 1868 also has William Henry Kirwan as the operator.

William Henry and Bridget ran the Hotel for several years, but struggled to keep the license. William fell from his horse² and suffered severe head injuries which he did not recover from and was sent to Yarra Bend Asylum³, Kew and then Ararat Lunatic Asylum on 26th June 1890 where he lived another nine years.

Bridget ran the hotel as the Temperance Hotel without a license from the late 1800s.

The following inmates of the Ararat Lunatic Asylum have died:William Henry Kirwan, 70 years of age, transferred from Yarra Bend, 26th June, 1890, syncope, following disease of the brain;⁴

Horsham Times, 7 Apr 1899

Bridget was very interested in the welfare of the local children, writing⁵ to the Education Department in 1892. A petition was being circulated requesting that Mr Sparke, the teacher for over 20 years be retained in Marysville. Bridget was not in support of this, believing that Mr Sparke was not a good teacher.

The Hotel had been delicensed, renamed The Temperance and Bridget ran it as a boarding house with various sons and daughters living with her from time to time.

Electoral Roll entries for 1903⁶ & 1909 contain Bridget Kirwan, Marysville, home duties. (Most of the women running accommodation houses gave their occupation as home duties).

By 1915 the Coney family had bought the Kirwan establishment and ran it as the "Carlisle".

Bridget died at her daughter, Belinda's house in Fairfield in 1921 and is buried with 3 of her sons in St Kilda Cemetery (RC A740).

Bridget and William Henry's children were:

4.1. Andrew James Valentine Kirwan (1862⁷ St Kilda - Died 1944 aged 83yrs).

Andrew Kirwan was involved with gold mining in the area and later specifically in the Cumberland area where his brother-in-law (William) Edward Chester had the successful Golden Secret mine. See Gold Folder for information on Andrew's various ventures.

Another photo in Ann Thomas "Yarra Stopping Places" book has Andrew Kirwan cutting palings however this photo resembles another photo of George Locke who was known to be a paler. See George Locke document.

References in Council reports indicated Andrew was regularly doing road works:

1886 - 16 chns of Marysville to Buxton Road.

1909 repairing the Marysville Bridge. *Healesville & Yarra Glen Guardian, 2 July 1909.*

From Andrew Kirwan, stating that several drains, including drain from septic tank at Roche's Hotel, all cross road and injure his land.Referred to inspector to report to next meeting, on motion of Crs.
Dawborn and Blackburn.
Healesville & Yarra Glen Guardian, 5 Oct 1918.

Cr Barton to ascertain whether Mr Andrew Kirwan is prepared to be Clerk of Works Marysville District. Healesville & Yarra Glen Guardian, 6 Mar 1937

Gold Mining on the Cumberland

Over the years Andrew and his brothers had interests in mining, in particular in the Cumberland region. Their involvement and fortunes fluctuated greatly as illustrated here.

Healesville & Yarra Glen Guardian, 25 Nov 1905 In mining matters there are great opportunities for legitimate investors in this district. To give an instance: Kirwan Bros. crushed 20 tons of stone for a yield of 45 ozs. of gold from their claim adjoining the Golden Bower mine near the Yarra Track. This result was obtained in about two months for two men. The stone was crushed at the battery of the Golden Bower Co. The claim is worked very economically, and present indications are very favourable.

Healesville & Yarra Glen Guardian, 24 Nov 1911 A Marysville Lease FORFEIT RECOMMENDED On the 20th inst., at Heidelberg, before Mr Warden Morrison, Emile Schelegel. of Melbourne, applied for forfeiture of mining lease No. 4803, Castlemaine, held by Andrew Kirwan, of Marysville and known as the Golden Bower⁸ mine. Applicant stated that the lessee had not fulfilled the covenants regarding labour, and that no work had been done on the land for the past 20 months. The ground had some time ago been worked, and a tunnel driven, but Schlegel stated that, owing to caving in, the tunnel would not be of any use to an incoming lessee. He informed the warden that if the present lease were forfeited and a new one issued, he had a syndicate with £1500 capital to work the licence ground.

Below are two later applications for 1933 at Cumberland Creek in Andrew's name.

Of interest is an application advertised in the Healesville & Yarra Glen Guardian, 22 June 1935 by members of the Elmore Family for a mining lease adjoining 'Kirwan's Reward' to be called 'Star of the East'.

- 4.2. **William Kirwan** (1863⁹, Inglewood ??), possibly died in infancy because a later son is called William Martin and reference¹⁰ is made to the Kirwans arriving in Marysville with only one son.
- 4.3. **George Martin Kirwan** (1866¹¹, Marysville 1940¹² Healesville). He was a gold miner along with his brothers Andrew and Charles. *See Gold Folder for information*.

George, with other miners, was reported assisting an old resident at Donovans Creek in 1896.

Healesville Guardian 30 Oct 1896

A very old resident of these parts named -W. V. Campbell, aged about 75 years, departed this life in a very sudden manner on Tuesday, the 20th inst., at Walker's hotel, Donovan's Creek. Mr. George Kirwan, who lives near deceased's place, found him in a very weak state in his hut on Frenchman's

Creek, and he, with Mr. Andrew Kirwan, Mr. M. Davis, Mr. Thos, Heron (saddler), and others carried him to Walker's hotel, a distance of nine miles, Mr. Walker's sons meeting them two miles from the hotel and assisted in carrying the rest of the way. Campbell was in a very weak state when he arrived

at the hotel. A doctor from Wood's Point was sent for and was in attendance as quickly as possible, but he could do nothing for deceased, who died on Tuesday night. The remains were taken to Marysville in a buggy by the Messrs. Kirwan and Walker, and were buried on Wednesday. Had it not

been for the good heartedness of Mr. George Kirwan the deceased would have died in his hut, away from a living soul, the death, of many a poor unfortunate digger.

George married **Alice Florence Allan** (1890-1963, buried Bulla Cemetery) in 1914 ¹³ while later in 1914 his brother, Gerald, married Alice's sister Emma Elizabeth Allan.

George did not join the soldiers going to WWI.

Ted Carter, aged 83 in 2001, a neighbour in Healesville remembers George taking him out prospecting in the early 1920s when Ted was a lad.

In 1930 Cr Hodges of Healesville Shire asks for work for George who is out of work.

George died in 1942 and Alice was living in Richmond at this time. Alice died in 1963 and her daughters, Mavis and Grace are buried with their mother as 'Kirwan'.

Alice and George had the following children -

- 4.3.1. Mavis Geraldine Kirwan (1916-2001),
- 4.3.2. George (? bef 1988),
- 4.3.3. Grace Florence Kirwan (1924-2003) of Richmond married ¹⁵ Philip James Stercula ¹⁶ in 1944 at St Patrick's Cathedral with the celebrations at the bride's mother's house. It was the height of WWII with US servicemen in Melbourne on R&R. Philip was in the US Navy on board USS 'Amycus' aged 24 and Grace was 20 ¹⁷. Like so many WWII marriages to US servicemen the marriages did not succeed as the men were required to return to US. Grace went back to using her maiden name by 1954 ¹⁸.
- 4.3.4. Jack (1916, registered Healesville-1988, Alfred Hospital) served in WWII in the Aust Rly Constr Coy (Mech Eqypt) married Gertrude Brettoner¹⁹ in the 1960s in the Registry Office. Jack worked with the railways and lived in Hawthorn East near the railway line. He died in the Alfred Hospital and donated his body to science. There were no children.
- 4.4. **Frances**²⁰ **Walter Kirwan** (1868²¹, Marysville 1926, buried in family grave at St Kilda) in 1891 was a witness to the Narbethong double murder having seen the murderer Colston pass as he worked on the road.²²

- 4.5. **John Kirwan** (1870²³, Marysville 1900²⁴ in Prince Alfred Hospital). He died from typhoid fever. Buried St Kilda cemetery. His mother and two brothers later added to the grave RC A 740.

- 4.7. **Charles Joseph Kirwan** (1873²⁷, Marysville 1935, Alexandra) 1917 Wolfram Mine lease with Sherman Gates:

4.8. **William Martin Kirwan** (1875 –1939, East Camberwell, buried at St Kilda cemetery with mother and 2 brothers). William lived with his single brothers in Falls Road Marysville and like them was a miner. He had been suffering for several years from Nephritis and Arteriosclerosis and finally died from heart failure in Nazareth House, a private aged care facility run by the Sisters of Nazareth and still operating in 2025 in East Camberwell. The Kirwans and Cussens were Irish Catholics who practised their faith. He never married.

4.9. Maria aka Ria Catherine (1877²⁸, Marysville – 30 Dec 1967, Parkville²⁹).

Maria married (William) Edward Chester (1871, Acheron river near Marysville - 1961, Fitzroy) in 1899, for wedding details see article below. Note - Maria's cousin Henry who gave her away and bridesmaid Nonie Kirwan were Uncle John Kirwan's son and daughter. Other cousins from Frances Kirwan's family in Stawell and John Kirwan's family attended.

WEDDING CHESTER-KIRWAN.

A very pretty wedding took place at St. Patrick's Cathedral, Melbourne, on Monday, the 20th November, the contracting parties being Mr. W. Chester, of Chesterville, Yarra Track, and Miss (Ria) Kirwan, of Marysville. The wedding was performed by the Very Rev. Dean McKenna. The bride, who was given away by her cousin, Mr. Henry Kirwan, who also acted as best man, wore a becoming gown of white figured silk, the usual wreath and veil, and carried a lovely bouquet. She was attended by Miss (Nonie) Kirwan, of Carlton, who looked very nice in white silk, flowers worn in the hair, and she carried a bouquet of white carnations and lilies of the valley. The bride groom's gift to the bride consisted of a gold opal brooch, and the bride's gift, to bridegroom, a beautiful bound prayer-book. The gift of the bride groom to the bridesmaid was a diamond and ruby brooch. The bride's travelling dress was a grey costume, with hat to match. Amongst the guests were Miss Kirwan, of Carlton; who was dressed in a costume of black silk. Miss

Kitty Kirwan, of Stawell, pale blue silk blouse, peaky skirt, blue straw hat. Miss Kelly, of Clifton Hill; grey and white silk hat to match. Miss Woods, navy blue costume. Mrs. Stevens, of St. Kilda, grey costume. Miss Kennedy, check silk and pink hat. Miss Ruby Cannon, of Carlton, brown and pink dress. Miss Julia Kirwan, black and white dress. Miss Janie Kirwan, pretty frock of white spotted muslin. Miss Ethel Stevens, pink frock. Miss Janie Kelly, black silk, and black and white hat. The wedding tea was served at residence of the bride's uncle. The bride received many useful presents. The happy couple left by the evening train for Bendigo, where the honeymoon is to be spent.

CHESTER-KIRWAN. -Silver Wedding -

On the 21st November, 1899, at St. Patrick's Cathedral, Melbourne, by the late Ven. Archpriest McKenna, Geelong, William Edward Chester, of Chesterville, to Maria Catherine Kirwan, of Marysville.

(Present address, 47 Queen's parade, Clifton Hill.)

4.10. **Gerald Cussen Kirwan** (c1881, Marysville – 1943, Fairfield). Gerald married Emma Elizabeth Allan (1895-1956, Richmond) in 1914. His brother George had already married Emma's sister Alice earlier in 1914. Gerald was working the Wolfram mine with his brother.

1914 South Melbourne, rubber worker

1916 Marysville, miner

Gerald was a tunneller in WWI in France. He gave his occupation as miner and next of kin Emma Elizabeth Kirwan.

Mr Gerald C. Kirwan, of the wolfram mine, Marysville, who enlisted and went into camp on the 25th September last, sailed on Wednesday, 18th inst.; to "do his bit" in assisting his comrades at the front. "Good luck Gerald."

Healesville & Yarra Glen Guardian, 28 Oct 1916

Mrs Emma Kirwan has received word from the Defence Department that her husband, Sapper G Kirwan, has been wounded in the head and

shoulder in France, and is now in hospital in England. *Healesville & Yarra Glen Guardian, 30 June 1917*

In 1910 she married William Thompson Hodgkinson (1887, Richmond-1927). They do not appear to have had any children.

Sadly William Thompson Hodgkinson died in 1927³² in a nasty accident.

Laborer's Unlucky Accident

CRUSHED BY LIFT. The death of William Thompson Hodgkinson, labourer, Gillies-street, Fairfield, the singularly unlucky victim of a lift accident, was investigated yesterday by the acting coroner, Mr. D. Grant. Evidence showed that at 8.2 a.m. on 14th inst. Hodgkinson was on the first floor of premises at 250 Flinders-street, Melbourne, where he was working, he was seen leaning over the lift well, and while in this position the lift descended, and inflicted fatal injuries to his head.

Hodgkinson was leaning over a wooden door 3 feet in height. Until 4 p.m. on the previous day there had been a screen of wire mesh attached to the wooden part of the door, forming the normal lift door, which would have rendered an accident of the kind impossible. The wire mesh had been removed in order to allow for the painting of the inside of the wooden frame to which it was attached. The lift that struck Hodgkinson contained a carpenter, who had just picked up his tools, and was on his way to reattach the mesh to the wood work. The Coroner found that death was received accidentally.

The following pages detail William Henry Kirwan's brothers and their families. Of note is John who ran the Shamrock Hotel in Alexandra for a time.

KIRWAN FAMILY in Victoria

John Kirwan married Jane Brookman in Ireland. Several of their sons came to Victoria in the late 1850s. Their youngest William Henry settled in Marysville and his family information appears on the previous pages.

Francis Brookman Kirwan (c1828, Rockview, Co Tipperary, Ireland – 1903³³, Dunolly, Vic).
 In Inglewood in 1859 he married Catherine/Kate Cussen³⁴ (c1838, Co Clare, Ireland35 – 188236, Dunolly, Vic). Catherine's sister Bridget married Francis brother William Henry in 1861.

An aside there were two unusual presents from a couple of gentlemen of a bag of flour and Mrs. Beaton's household book.
 - Martin Minogue, a Clerk of Courts had worked at Nhill and Benalla prior to his death aged 44 in 1912³⁹.

Table Talk, Fri 24 January 1896

MINOGUE-KIRWAN.-A very large assemblage was present at St. Patrick's Roman Catholic Church, Stawell, on January 15, to witness the marriage of Mr. M. J. Minogue, Clerk of Courts at Stawell, and eldest son of the late Mr. John Minogue, of "Estcourt," Wangaratta, with Miss Ellen (Nellie) Kirwan, second daughter of Mr. Francis Kirwan, of Dunolly. The ceremony was performed by the Rev. Father Shanaghan, of Hamilton, assisted by the Rev. Father Lynch. The bride, who was given away by her brother, Mr. James Kirwan, was attended by four bridesmaids, Misses Kitty and Fanny Kirwan, sisters of the bride, Miss Annie Minogue, sister of the

bridegroom, and Miss Katie Kirwan, cousin of the bride, Mr. J. Kirwan acted as best man, and Miss Swan played the "Wedding March." The bridal toilette was of rich cream brocaded silk made with court train. The bodice had the double box pleat back and soft frills of chiffon were used as a trimming, with sprays of natural orange blossom. The large sleeves fell in wide puffs to the elbow, finishing off with prettily fashioned bows of the brocade. A coronet of orange blossom was worn on the head, and over it was arranged a long tulle veil, which reached to the end of the train. She carried a beautiful shower bouquet composed of white flowers veiled in fronds of asparagus and other delicate ferns. The first bridesmaid, Miss Kitty Kirwan, (sister of the bride)

and Miss Katie Kirwan (cousin of the bride), were becomingly gowned in white silk. The bodices had gathered yokes outlined with folds of chiffon, blouselike fronts and full bishop sleeves. Miss Annie Minogue (sister of the bridegroom), and Miss Fanny Kirwan (sister of the bride), wore eau de-nil silk. These costumes were tastefully embellished with butterfly bows and pleated collar of chiffon, gigot sleeves completed with smart bows at the wrist. They all carried charming posies of white flowers with ribbon streamers, and flowers were also worn in the hair. The first two bridesmaids, Miss Kitty Kirwan and Miss Annie Minogue, wore the bridegroom's gift of gold brooches, the former's set in pearls, and the latter's an amethyst brooch. After the ceremony and nuptial mass, the wedding party proceeded to the Commercial Hotel, where the wedding breakfast was served in the large dining-room, which had been artistically decorated with flowers and evergreens. The table, set off by the wedding cake of three tiers, was done with white carnations and trails of asparagus fern. Later in the afternoon the wedding party drove to the Great Western, where Mr. and Mrs. Minogue took the train en route for Launceston for their honeymoon. The going away gown was fawn faille françoise, with design in pale blue silk, made with godet skirt, and bodice of brown and blue shot brocade, full in front, and box-pleated back. Gigot sleeves of the material were smartened by a gauntlet cuff of the silk. A smart white toque, surmounted with goffern wings and pale pink roses, completed her toilette.

Mr. John Cane (to bride) silver hot water kettle, to bridegroom, silver morocco flask. Madame McIntosh, pearl ring. A friend, silver toast rack. Mr. and Mrs. J. Rowan silver mounted salad bowl. Mr. and Mrs. D. McLean silver butter dish. Mr. and Mrs. A. I. Payne, Dresden china ornament. Mr. and Mrs. P. Galbraith pair ruby jewel caskets. Mr. and Mrs. T. G. Crera, silver butter dish. 2. **Thomas Kirwan** (c1829 – 1891, Kingower⁴²) married Sarah Cunningham. They had three children in Inglewood. Was Thomas part of this family? The brothers had connections with Inglewood in the 1860s. Very little information could be found.

The following article in 1888 mentions Inglewood and Kingower connections which would support the fact that this Thomas Kirwan fits with this family.

Bendigo Advertiser, 2 June 1888

INGLEWOOD. (From our own correspondent.)

Death in hospital.— An old man named Thomas Kirwan, between sixty and seventy years of age, who was brought in from Kingower by Mounted Constable Madigan and admitted into the hospital on Tuesday, died in that institution on Thursday morning. The cause of death was general debility, from old age and want of proper nourishment. The deceased was an inmate of the hospital some time back, but repeatedly left of his own accord. Two or three months ago the police in consequence of numerous complaints took him into custody, and he was sent to gaol for a month on a charge of vagrancy. Since his discharge he made his way back to Kingower, in which locality, it is stated, he had previously lived for a lengthy period.

JOHN KIRWAN of ALEXANDRA

John Kirwan ran the Shamrock Hotel in Alexandra from 1869 -

3. **John (Brookman) Kirwan** (c1833 Tuam, Co Galway, Ireland⁴⁸ – 1903, Clifton Hill⁴⁹ from influenza) married Honoria Shiels (c1843 Naran, Co Meath, Ireland-1884 Alexandra) in 1860 at St Mary's, Inglewood. John Kirwan was a store keeper in Inglewood when he married Honoria.

In 1869, a couple of years after brother William Henry and Bridget came to Marysville, John and Honoria moved to Alexandra where John held the licence for the Shamrock Hotel. The family lived on in Alexandra. Disaster struck when the Hotel burnt down in 1883 and John's mother in law and his wife both died in 1884. John was struggling with expenses and became insolvent in May 1885.

Leader, 9 May 1885

John Kirwan, of Alexandra, licensed victualler.

Causes of insolvency: Losses through insolvent's hotel being destroyed by fire in November, 1883, falling off in business as licensed victualler at Alexandra and depreciation of property there owing to decrease of population, having had to incur heavy expenses in consequence of sickness and death in family and paying large interest an borrowed money. Liabilities, £1608 4s. 10d.; assets, £1082 10s. 4d.; deficiency, £525 11s. 6d. Mr. Jacomb, assignee.

John and remaining family moved to Carlton, then North Fitzroy area after his troubles in Alexandra. It is interesting to see that this family was in touch with John's brothers - Francis - with Katie being bridesmaid to Ellen and William Henry - with John's son Henry acting in a senior role and his sisters being mentioned at Maria Catherine's wedding to William Chester in 1899.

The turn of the century brought John's death in 1903 from influenza and a series of premature deaths amongst his daughters from 1899 to 1907, all registered in Clifton Hill. Death Registrations in hand.

John and Honoria's children:

- 3.1. **Marie Theresa Kirwan** (1863, Inglewood⁵⁰ 1922, Richmond). Maria is with her siblings at Portland Street, Richmond when they first appear on the electoral rolls in 1909 at this address. She is with them until her death in 1922.
- 3.2. **Caroline Kirwan** (1865, Inglewood⁵¹ 1899, Carlton⁵² from Phthisis (TB)).
- 3.3. **Peter Kirwan** (pos 1867,? 1938 Bega, NSW⁵³). John and Honoria Kirwan are listed as parents on Peter's death certificate, although Peter is not listed on his father's death certificate in 1903. Birth registration not found. The family were in Inglewood in 1865 and then in Alexandra in 1869. Honoria's children were born every two years which would suggest Peter was born in 1867 when the family was in transit between Inglewood and Alexandra.

Peter left home at a young age. Was there a falling out?

Peter married Bridget Murley in Sydney in 1883, aged 19. He was one of the original settlers on the Bega Village Settlement. Their children bear the names of the Kirwan siblings.

 Julia lived with her brothers Henry, bootmaker and John, French polisher in Portland St, Richmond from 1912 til 1942 including sister Maria til 1922.
- 3.5. **Henry Kirwan** (6 June 1871, Alexandra⁵⁶ 1948, Richmond) There is some confusion because the 1871 birth registration is for John Brookman Kirwan. But there is a brother John Andrew, born 1876.

The page from the Alexandra registration book with entries by John Smith, the registrar is curious as births (December, June & July) are entered on 22 September 1871. John Kirwan, publican's signature is very shaky. Was there confusion and the father's name entered as the child's name? It's unlikely John and Honoria had a copy of the birth entry or checked the entry.

"Henry" is listed on brother John Andrew's birth registration in 1876, aged 5 and on father's death certificate after Julia with a John after Kate. Henry Kirwan cousin of Maria Catherine Kirwan gave her away at her wedding to William Chester in 1899. See entry for Maria Catherine Kirwan.

Henry was a bootmaker. After the death of so many family members, the siblings Maria, Henry, John and Julia Kirwan lived at 4 Portland St, Richmond from 1909.

- 3.6. **Kate/Cath Kirwan** (1873, Alexandra⁵⁷ 1907 Fitzroy⁵⁸, of Phthisis (TB)). Katie was bridesmaid to her cousin Ellen (Francis' daughter) in 1896.
- 3.7. **John Andrew Kirwan** (1876, Alexandra⁵⁹⁶⁰--1953, Fitzroy) note Henry aged 5 was listed on John's birth registration. John found living in Tanner St, Richmond, salesman in 1919.

- 3.9. **Jane Kirwan** (c1881 1904, Clifton Hill⁶³ of Phthisis (TB)).

Siblings Julia, Maria, Henry, bootmaker, and John, French polisher, then lived together at 4 Portland St, Richmond.
