AT 8PM ON WEDNESDAY 14TH MAY, 1980.

The subject of the meeting will be the story of Montsalvat and discussion will be led by Mr. Sigmund Jorgensen.

Montsalvat was commenced in 1935 by Sigmund's father, the late Justus Jorgensen. It comprises an extensive complex of buildings of mudbrick, local mudstone and other natural materials. Since its inception it has been home to many local artists and it has come to form the focus of the local artistic community. In recent years it has become a tourist attraction and a centre for cultural events such as the well known musical evenings. Most of us know a little about Montsalvat but it will be of great interest to hear the whole of the story from someone who h as been personally involved.

SOCIETY EXCURSION SUNDAY 25th MAY

On Sunday 25th May the society will visit a number of buildings and locations of historical interest in the Eltham area. Transport is to be by private cars. The tour will commence at 1.30p.m. at the old timber cottage in Ely Street at the rear of the Eltham High School. An inspection of the interior of the cottage has been arranged. Eltham pioneer Frederick Falkiner lived in this cottage which is soon to be transferred to the shire council. Details of other locations to be visited are still being finalized.
