PREFACE :

SYNOPSIS

This research report contains an investigation of significant historical and archaeological sites and structures in the Upper Yarra Valley and Dandenong Ranges Region, and is designed to assist the Upper Yarra Valley and Dandenong Ranges Authority in carrying out the investigation requirements for the preparation of its strategy plan. It also analyses the various techniques and measures which can be used to conserve historically significant sites and structures, and suggests various courses of action for the Authority.

The basic premise of the report is that sites and structures of historical and archaeological significance are a limited and valued resource which should be evaluated and conservatively managed.

The specific objectives of the study were :

- To examine the costs and benefits of conserving historically and archaeologically significant sites and structures.
- To outline the general pre-history and history of the region so that its historically and archaeologically significant sites and structures can be examined in their proper historical perspective.
- To carry out a survey of all sites and structures within the region which may be significant.
- To evaluate the concept of significance and to establish a set of criteria and guidelines for the evaluation and classification of the historical and archaeological sites and structures within the region, and to evaluate and classify them according to these criteria.
- To compile an inventory of sites and structures of historical and archaeological significance within the region. To identify critical issues and problems with respect to their conservation, and to suggest possible courses of action for the conservation of the most significant of these sites and structures.

- To analyse the relevant legislation for the conservation of sites and structures of historical and archaeological significance, and to discuss how conservation can be put into practice.
- To examine possible courses of action for the Upper Yarra Valley and Dandenong Ranges Authority to conserve regionally significant historical and archaeological sites and structures.
