Pursuant to the provisions of the Local Government Acts payment is hereby demanded from you of a rate as shown on the reverse side of this notice - of the last annual valuation, due and payable on the 10th day of December, 1967 of the property of which you are the owner or occupier.

Please TAKE NOTICE that the Bendigo Sewerage Authority pursuant to the provisions of the "Sewerage District Act", has made a Rating By-Law (a copy of which may be inspected without charge at the Authority's Offices during normal business hours).
