ALLEGED ILLEGAL GOLD-SELLING.

CHARGE AGAINST DETECTIVE.

ACCUSED DISCHARGED.

MELBOURNE, Thursday.

The charge against John William Shuttleworth, who is employed by the Mineowners' Association as a detective, of having sold gold at the Masonic Shades Hotel, contrary to the provisions of the Goldbuyers Act, was called on at the Bendigo Court to-day.

The solicitor for the prosecution asked that the case be discharged, and his application was granted. Fowler, the Informant, was ordered to pay Shuttleworth £2 2s costs. Shuttleworth states that he intends to issue writs against all those who brought about, his arrest for malicious prosecution, as well as for having committed an illegal act.

### TRANSFER OF LICENSES.

At the annual Licensing Court the police objected to the granting of the renewal of the licenses of the Five Lions Hotel, the Bendigo Hotel, and the Masonic Shades Hotel, the ground being that the

hotels in question had figured in the recent

illicit gold-buying cases heard in the Bendigo Court. in the case of the Five Lions and Bendigo Hotels, the husbands of the licensees were convicted; while in the case of the Masonic Shades one of the con- victed persons was alleged to have used

the hotel for the purpose of buying gold. Judge Johnston, Messrs. E. N. Moore and, A. Barlow P.M.'s, who presided, granted the applications. Judge Johnston remarked

that the attitude of the Bench towards such cases was that where there was any reasonable suspicion that gold-buying was going on it would be a good case for delicensing the premises
