Minutes of Council Meeting held at Warrnambool YMCA on Mon. 10/3/75 9.00a.m.

Members in attendance.

The minutes of the previous were read and accepted .

Moved Rod Sach, Seconded Richard Godycki. Carried.

Matters arising from those minutes.

1. Geelong and Warrnambool Associations have reached an amicable agreement in regard to their financial arrangements.
2. VAVA Constitution :- No comments were received from any Country Association.
3. No reply has been received from Colac Association, no further correspondence will be sent to their Association from the VCVC.
4. M.Mansfield and A.Lowe have prepared player registration forms for each Country Association. These forms will be forwarded to each Country Association Secretary soon after Easter. Each Club Secretary will be asked to prepare a form, with the Country Championships being the final date for return.
5. Country VAVA representatives;- Richard Godycki (Geelong) was elected.

General Business.

1. An official approach is to be made to the VAVA Organising Committee for the 1st Asian Volleyball games. Several Country Associations are interested in having International teams play Demonstration matches at their Centres.

Audience capacities Approx. only, Warrnambool 1500, Wangaratta 750,
Bendigo 800, Morwell 800.

Each host Association would be responsible for costs of transport, travel, accomodation and incidentals. Local sponsorships at each Centre being the most likely method of funding such matches.

2. Association affiliation fee of \$20.00 is now due and payable.

3. Country Championships at ^{Wangaratta} Warrnambool June 14, 15 and 16.

Hall booked, Entry fee \$25.00 including \$5.00 fidelity bond.

Entries will be called for by the VCVC Secretary who will also have the final authority on the match draw.

The top VAVA referees are to be approached to officiate at the Grand Finals.

All matches are to be played 'best of 5' sets.

The VCVC will be responsible for compilation and distribution of playing and referee draws.

The host Association will be responsible for covering the costs of the Championships. Moved Alan Lowe, seconded Richard Godycki, Carried.

4. All Associations are asked to forward their starting and finishing local Competition dates for 1975 to the Secretary as soon as possible please include any Tournament dates you may have decided upon.
5. A general discussion took place about the frequency of Tournaments. The conclusion reached was that no fixed number of Tournaments / year could be set.
6. M.Mansfield mentioned that AVF were likely to alter the age of juniors from U18 to U20 some time during 1975..

There being no further business the Meeting closed at 10.10a.m.
