1980 - Country Championships Report.

Held at Corio Leisure Time Centre, Geelong

Successes

1. 3 ball system.

Completion of matches were quicker.

eg:- Sat., there were 4, 5 set matches, and at the end of the night, the final match finished 60 min. late.

Sun., there were 4, 5 set matches, and at the end of the night, the final match finished, 50 min. late.

2. Referees panel, especially in Div. 1.

This panel has formed a solid basis for the future.

3. The G.A.V.A. had 3 people in charge, who kept a watchful eye on volleyballs and ensuring that matches started on time. With the help of the referees, the results were that there was very little delay between matches and no match balls were lost.

4. Introduction of Div. 2.

There were some teething problems, but in general Div. 2. was successful.

5. Use of 4 courts in single venue.

The use of 4 courts enabled all matches to be finished on Sunday.

Failures

1. Unable to omit duty teams.

2. Associations leaving accommodation bookings too late.

3. Finalisation of teams participating in Championships is far too late. Unnecessary burden is placed on the host association prior to the championships.

However in this instant Div. 2. can be excused.

Draws should be submitted 2 to 3 weeks before the tournament.

4. Failure of VCVC Executive Committee to make decisions
eg:- Swan Hill, 5 players in final match.

It was decided that such a decision would be left to the tournament director. Such a decision should never be left to him.

5. Div. 2. teams unable to use international scoresheets.
6. Mix up in finals participants in Div. 2. Mens.

Future Tournament Suggestions

1. To stop overloading of matches played per court per day, and to ensure that only finals are played on Mondays :-
 - (a) at least 4 courts are needed
 - (b) or each Division could be run at separate venues.
2. Insist on 4 linesmen for every match in each division.
3. Upgrade Div. 1. Mens Perpetual Trophy.
4. Change in structure of ladder.

 - (b) Percentage in sets .
 - (c) Percentage in points .
