Report V.C.V.C. U 20 Championships 1980.

Host Association Latrobe Valley, 6<sup>th</sup> + 7<sup>th</sup> Dec.

ENTRIES. Bendigo, Geelong, Latrobe Valley + Warrnambool Men + Women. After discussion with the V.C.V.C. Executive it was decided that the host Association provide a further Mens + Womens team to extend the draw + provide competing teams four games rather than three

DRAW This was arranged using two courts and playing Mens and Womens matches alternately. i.e. 2 mens followed by 2 women. This removed the need for teams to play consecutive matches but did require Men to provide duty for Womens matches + vice versa.

REFEREES. Not all teams provided a referee who was independent of the team, many were also coaching, this made the provision of a referee + umpire difficult. As a result those who were not tied to a team + Tomas Santamarra were very busy.

\* We recommend that in future under age championships that the team must supply at least one referee who has no other role.

REGISTRATION.

11 Players were found to be not listed as U'20 on the current VCVC player register. Geelong 4, Latrobe Valley 3, Warrnambool 3, Bendigo 1. Association officials certified these players' eligibility, however it indicates the need to check registrations by Associations carefully. In all cases the above players have been registered (and the Association billed) as senior.

FINANCE.

The Association was indeed fortunate to secure a Major Sponsorship of \$250 cash from the Moe + District Credit Union. This offset to a very large extent the cost of trophies which would have been a large expenditure against the low income from entry fees. Overall there was a deficit of some \$84-16 which we would like the VCVC to consider when allocating grant money for championships. Balance Sheet attached.
