

ASSOCIATION REPORT: Compiled by Mrs Terrie Crozier.

The 1982 Country Under 17 Championships were one of the most profitable Championships held under the auspices of V.C.V.C. This was largely due to cheaper stadium hire and volunteer work carried out by members of the G.V.A.V.A.

As the championships ran smoothly for the weekend, there being no major problems one can say that they were successful. Five boys and 5 girls teams participated. The final placings were:

BOYS: Bendigo, Goulburn Valley, Warrnambool, Seymour, Latrobe Valley.

GIRLS: Geelong, Bendigo, Goulburn Valley, Latrobe Valley, Seymour.

Mount Martha Army Apprestice School was given permission to play in the boys competition by V.C.V.C. but were ineligible to win the title. Therefore, all games were officially scored as byes.

ORGANIZATION AND ADMINISTRATION

As there are no ground rules laid down by V.C.V.C. for the organization of championships, it was difficult to know whether sufficient preparation were made. I would like to recommend to V.C.V.C. that a check list be handed to all host Associations on their acceptance of the championships. This list should include all items that need to be supplied and tasks that need to be carried out prior to and over the weekend.

Due to the late withdrawal of Warrnambool girls, the playing schedule had to be revised and not received by participating Associations until two days prior to the weekend. Withdrawal of teams after the final closing date of entries causes problems for the host Association, participating teams and the Chief Referee. Obviously the penalty for withdrawal is not sufficient, and has to be greatly increased to prevent continual reoccurrence. Perhaps a \$500.00 fine and 12 months suspension from entering teams in any championship may make Associations think before entering teams that don't exist.

TIME ALLOWANCE

Time allowance of 90 minutes per match once again proved to be inadequate. Two out of every three matches in the boy's competition exceeded the time allowed, causing play in this section to finish at 12 midnight Saturday. This was after allowing a 90 Minute "catch-up" time slot at 3.00 for this section. With most Junior Divisions in country Volleyball becoming more even and the equality of senior competition, due to the introduction of Division 2, one can no longer depend on the "quick 3 setter" to catch up on time. Perhaps every second game could be given a time allowance of 120 minutes, giving plenty of catch-up time during the weekend.

FINANCIAL REPORT

Financially the tournament was a great success, showing a net profit of \$197.17. As stated previously, this was largely due to cheaper stadium hire. However, large savings were made by asking Association members, mums and dads to volunteer time to work in such areas as First Aid, (qualified nursing sisters were used), Doormen, score officials and stadium cleaning. Molten leather Volleyballs were used, and no damage was done. Therefore, I could not justify claiming any depreciation and these balls are now being used for local competition.
