Associations etc. are reminded that V.A.V.A. policy does not permit unaffiliated players to compete with affiliated players without V.A.V.A. approval.

8.0 DELEGATES REPORTS:

A.V.F.
J.Barker (A.V.F. V.President) provided an extensive report. Improved communications - phone link between all Board members each month. Finance situation looks healthier since a number of expenditure items cut. Sole rights for balls, for A.V.F. events, being re-negotiated. Request from External Affairs for Australian coach to visit Sri Lanka.

Moved Glasson/McColl that we approve in principle T.Santamaria coaching in Sri Lanka provided that he has adequate workers comp. cover and appropriate arrangements are made with the S.E.D. regarding leave and salary. CARRIED.

Coaches & Managers reports from past tours to be collated to extract recommendations for future policy. National Institute of Sport, not to include extra sports at present, provides some funding for National Teams.
Grant of \$2000 available to assist 1 coach attend '84 Olympics.
A.V.F.R.C. to come under direct control of A.V.F.

Technical information etc. to be collected from States for distribution
N.C.D. presented a format for a Schools Tournament in addition to the A.S.S.S.F. Chanpionships to be circulated for comment.
