

RECORD SECRETARY'S ANNUAL REPORT

14/6/80

I regret that I am unable to provide any details on this years registration figures, due to two factors. Firstly, the date of the A.G.M. has been brought forward so that the updated returns have not been fully processed and secondly, I just do not have the total registration returns from Associations.

The due date for registration returns was set at May 24th this year, and having been issued on the 9th April, I felt was sufficient time for Associations to undertake the update. Had all returns been in on time, the processing of the returns could have been completed in time for this meeting.

In the 1979 report, I suggested that the time for penalties for late return of registrations, fee's and Championship entries, was fast approaching. I consider the time has arrived, and hereby give notice that at the next General meeting of the Council, I will move for a penalty of \$50 be imposed on any Association who fails to meet a due date for return of registration details, interim or final registration and affiliation fees and Championship entries, on the provision that at least one clear month's notice precedes the due date set. Any outstanding fines should render that Association suspended from all competition within the State.

When the returns are received, I would expect to see an increase in the overall position of registered players. It is very pleasing to note the affiliation of the Hamilton Association, and I urge each and every one of you to assist this new group if at all possible. The Latrobe Valley Association have also commenced a new competition at Moe, and these numbers will assist in increasing our totals. I should also report that a resurgence of interest in both Ballarat and Swan Hill is apparent, so we should look forward to possible growth in these areas.

The only problem area I can for-see is Wangaratta. From the reports I have heard, the competition is dwindling and runs the risk of losing its time allocation in the stadium. The Council should consider any way in which it may assist to strengthen this Association.

A more detailed report on figures and statistics will be provided at the next conference later in the year.
