The 2nd Oceania Volleyball Championships will be held in Nelson, New Zealand, during the period 18th-24th January, 1976. Nominations are hereby called for to fill the positions as listed above.

Duties of Officials are as follows:

GENERAL MANAGER:.....(1 position)

1. The General Manager shall be responsible to the A.V.F.Inc. for the management and control of the Australian Volleyball Teams from the time of assembly until the return of the teams to Australia.
2. He shall be required to present to the A.V.F.Inc. within three(3) months of his return to Australia a detailed report and statement of accounts covering the full activities of the teams during the period of his administration.
3. He shall immediately report to the A.V.F. Inc. any serious breaches of discipline or misconduct by any member or members of teams.
4. He shall be the spokesman for the A.V.F. Inc. on matters of Official -semi official nature during the period of his administration.
5. When there is no Assistant General Manager, he shall also:-
 - a. Represent the Australian Teams at Official functions when required.
 - b. Organise team entertainment.
 - c. Organise team parades for Opening and Closing ceremonies.

General: The General Manager will have full disciplinary powers over all players of teams as well as Team Managers and Coaches. He will carry disciplinary powers including the right to send any player back to Australia if any offence committed so warrants. As overall leader of 24 players, 2 Team Managers, 4 coaches and referees attached to the team, the appointed General Manager should be one who has proved capable of getting-on with people, whose integrity is above reproach and is of healthy and sober habits.

TEAM MANAGERS.(1 -Women & 1 Men)

DUTIES:

The duties of Team Managers shall be:-

1. To assume such authority and responsibility as may be delegated by the General Manager.
2. To observe only directions and instructions of the General Manager.
3. To confer with the General Manager regarding the wishes(if any) of the A.V.F.Inc. or the General Manager.
4. To appreciate that his/her sole responsibility is to the General Manager and to disregard any instruction from other persons or bodies which may be contrary to the instructions of the General Manager.
5. To supervise and assume responsibility for the training, travel, discipline, behaviour and general well-being of the team under his/her control.
6. To report immediately to the General Manager any misconduct or breach of discipline of any member of the team under his/her control and to abide by the decision of the General Manager with respect thereto.
7. To present to the General Manager within one(1) month of his/her return to Australia, a full report covering the performances and behaviour of the team under his/her control.
8. To present to the General Manager.....

General: Following appointment, Team Managers will be expected to confirm their appointment by the signing of an agreement that they undertake to abide by the Rules of Duties of Team Managers.
The period of the appointment shall terminate following the A.V.F.Inc. acknowledging the receipt of the General Manager's Report and any report that Team Managers may be called upon to provide.
