

THIS AGREEMENT is made the day of August, 1982
between CRYSTAL EGG COMPANY of Garsed Street Bendigo ("Crystal")
of the one part and THE PRODUCERS listed in the Schedule
hereto ("the Producers") of the other part

WHEREAS:

- A. Crystal is an agent of the Victorian Egg Marketing Board ("the Board") for the purposes of receiving eggs and grading handling selling and disposing or otherwise dealing with eggs.
- B. The Producers are all producers in the area in which Crystal is authorised by the Board.
- C. Crystal has been requested by the Board to acquire new equipment to carry out its obligations as agent of the Board.
- D. The recent increases in wages of storemen and packers employed by Crystal permit Crystal to apply to the Board for an increase in the rates it can charge Producers for the services it carries out.
- E. Each of the Producers is entitled to apply to the Board for a permit to grade test mark or stamp eggs produced by it.
- F. Crystal has agreed with the Producers not to make an application for any increase upon the terms and conditions of this agreement.

NOW THIS AGREEMENT WITNESSES that:

1. The Producers agree that they will supply all eggs produced by them to Crystal and that they will not, nor will they apply to the Board for a permit to, grade test mark or stamp eggs during the term of this agreement.

2. In consideration of the Producers so agreeing Crystal agrees with the Producers that it will not apply to the Board for an increase in its charges for grading testing marking and stamping eggs received from the Producers:
 - (a) prior to 1st February 1983; and
 - (b) after that date unless such increase is not greater than any increase in the CPI/cost per hour of storemen and packers for the period from 1st August 1982 to the date of such increase.
3. The obligation of the Producers is joint and several, and if any of the Producers is in breach of its obligations hereunder Crystal will, at its discretion, no longer be bound by the provisions of this agreement.
4. Each of the Producers agrees with the others not to breach the terms of this agreement.
5. Each of the Producers agrees with Crystal and each other that if at any time they cease to be producers of eggs or dispose of their hens to any person they will make it a term of any such disposal that the acquirer will enter into an agreement with the other parties to this agreement agreeing to be bound by similar obligations.
6. This agreement will remain in force until the earlier of:
 - (a) 30th July 1982; and
 - (b) the date upon which Crystal gives notice to the Producers of its intention to terminate this agreement in accordance with clause 3.
