Meeting 03.01.1861

Meeting 28.03.1861

1. Town Clerk to write to Commissioner of Public Works for fencing of corner of Bay & Rouse Streets, (P.O. Reserve) re sand drifting on to it.

Meeting 23.04.1861

- 1. Letter to Hobsons Bay Railway Co to complete Raglan Street to the Station, for a footbridge over the railway in accordance with promise to do so.

Meeting decided to re convene on 02.01.1862, close for Christmas.

Meting 19.12.1861

Sale of goods on Beach Street, no signs allowed.

Meeting 09.01.1862

- 1. Clean beach of seaweed between Sandridge Baths & Railway Jetty.
- 2. Owners of un/occupied land be made to fence same.

Meeting 16.01.1862

Letter to Commissioner of Police to appoint Policeman to Town Jetty.

Appropriation of land for a reserve between Station Place and Melbourne Hobson Bay Railway.

Meeting 30.01.1862

Re not enough water from Yan Yean Reservoir to the municipality – letter to Commissioner.

Meeting 13.02.1862

- 1. Erect Gas lamps west side of Bay Street between Market Reserve and new Town Hall site.
- 2. Cost of lighting is 3 pence in the pound spent on it in the municipality.

Meeting 20.02.1862
