I am researching the history of the Ballarat tramways, and my query relates to the Municipal Tramways Trust of Adelaide archives (GRG 22).

I require a search of the archives for the period October and November 1909. A tram depot in Ballarat burned down early in October 1909, and it is known that by mid-November 1909 the Electric Supply Company of Victoria (the operator of the Ballarat tramways) had acquired two surplus horse trams from Adelaide as a replacement for the trams lost in the fire. This co-incided with the period that the horse tramways in Adelaide were being electrified, hence there were surplus horsecars available.

The sections of the Archives that appear to be relevant to my search are:

Press 1089D - 29	Secretary's letter books, MTT, 1908-1916.
Press 1089D - 30	Board room letter books 1907-1935.
Press 1089D - 31	Letters sent 1907-1909.
Press 1089D - 34	Letters sent 1907-1935.
Press 1089D - 35	Internal memoranda sent 1907-1935.

Therefore the search would involve a perusal of these archives for the period October and November 1909. Presumably the records, if they still exist, would show a request from the Electric Supply Company for surplus rolling stock; internal inquiries as to what is available; a reply from the MTT that there are trams available for purchase; and correspondence concerning acceptance and arrangements for delivery.
