Amendment to By-law

Pursuant to the provisions of Section 71 of the State Electricity Commission Act 1958 the State Electricity Commission of Victoria hereby subject to the consent of the Governor-in-Council further amends the By-law made pursuant to the said section and approved by the Governor-in-Council by and with the advice of the executive council thereof on the 9th day of March, 1937, as amended the 7th day of February, 1938, the 31st day of January, 1939, the 23rd day of November, 1942, the 25th day of October, 1943, the 4th day of February, 1947, the 30th day of August, 1949, the 12th day of June, 1951, the 24th day of June, 1951, the 25th day of October, 1955, the 2nd day of July, 1958, and the 15th day of January, 1963, and the schedules to the said By-laws as follows that is to sav:-

1. For the First Schedule to the said By-law shall be substituted the following Schedule:-

BALLARAT

The following shall be the fares to be paid by passengers at Ballarát, that is to say:-

Adult Fares

The fare of an adult carried on the whole or part of any one of the following journeys in which for the purpose of this Schedule the term "City" means the intersection of Sturt Street and Lydiard Street, Ballarat, shall be:-

(A) City Section - Fare 3d.

Between "City" and the intersection of Victoria and Main Streets.

Between "City" and the intersection of Sturt and Dawson Streets.

Between "City" and the intersection of Lydiard and Market Streets.

City Section - Fare 4d.

Between the intersection of Sturt and Dawson Streets and the intersection of Victoria and Main Streets.

Between the intersection of Sturt and Dawson Streets and the intersection of Lydiard and Market Streets. Single Section - Fare 6d.

Between "City" and the intersection of Victoria and Queen Streets.

Between "City" and the intersection of Grant and Barkly Streets.

Between "City" and the intersection of Lydiard and Brougham Streets.

Between "City" and the intersection of Sturt and Drummond Streets.

Between the intersection of Queen Street and Victoria Street and the terminus at Stawell Street.

Between the intersection of Grant Street and Barkly Street and the terminus at Cobden Street.

Between the intersection of Brougham Street and Lydiard Street and the terminus at Norman Street.

Between the intersection of Drummond Street and Sturt Street and the intersection of Alfred Street and Sturt Street West.

Between the intersection of Drummond Street and Sturt Street and the intersection of Haddon Street and Wendouree Parade.

Between the intersection of Drummond Street and Sturt Street and the intersection of Darling Street and Skipton Street.

Between the intersection of Alfred Street and Sturt Street West and the terminus at the Gardens Pavilion. Between the intersection of Haddon Street and Wendouree Parade and the terminus at the Gardens Pavilion.

Between the intersection of Darling Street and Skipton Street and the intersection of Vickers Street and Albert Street, Sebastopol.

Between the intersection of Vickers Street and Albert Street and the terminus at Queen Street, Sebastopol.

(B) Two Sections - Fare 8d.

Between "City" and the terminus at the intersection of Stawell and Victoria Streets.

Between "City" and the terminus at the intersection of Cobden and Barkly Streets.

Between "City" and the terminus at the intersection of Norman and Lydiard Streets.

Between "City" and the intersection of Alfred and Sturt Streets.

Between "City" and the intersection of Haddon Street and Wendouree Parade.

Between "City" and the intersection of Darling and Skipton Streets.

Between the intersection of Sturt and Drummond Streets and the Gardens Pavilion.

Between the intersection of Sturt and Drummond Streets and the intersection of Vickers and Albert Streets, Sebastopol. Between the intersection of Darling and Skipton Streets and the terminus at Queen Street, Sebastopol.

(C) Three Sections - Fare 10d.

Between "City" and the Gardens Pavilion.

Between "City" and the intersection of Vickers and Albert Streets, Sebastopol.

Between the intersection of Sturt and Drummond Streets and the terminus at Queen Street, Sebastopol.

(D) Four Sections - Fare 1/-d.

Between "City" and the terminus at Queen Street, Sebastopol.

Children's Fares

The fare for a child under 14 years of age carried on the whole or any part of any one of the said journeys in respect of which the adult fare payable does not exceed 4d. shall be 2d., where the adult fare payable is 6d. or 8d. shall be 3d., where the adult fare payable is 10d. or 1/-d. shall be 5d.

A child under 4 years of age, held in the arms of an adult passenger, shall be carried free of charge.

Pensioners Concession Fares

The fare of any person to whom has been issued a Pensioners' Fare Concession Certificate under the authority of Her Majesty's Minister of Transport for the State of Victoria and who produces such certificate to the conductor of a tramcar of the Commission during the currency of such certificate –

- (a) in respect of any journey for which the adult fare is not more than 4d. shall be 2d.;
- (b) where the adult fare payable is 6d. or 8d. shall be 3d.; and
- (c) where the adult fare payable is 10d. or 1/-d. shall be 5d."
- 2. For the Second Schedule to the said By-law shall be substituted the following Schedule:-

"SECOND SCHEDULE

BENDIGO

The following shall be the fares to be paid by passengers at Bendigo, that is to say:-

Adult Fares

The fare of an adult carried on the whole or part of any one of the following journeys in which for the purpose of this Schedule the term "City" means the intersection of Mitchell, View and High Streets with Pall Mall and known as Charing Cross, Bendigo, shall be:-

(A) City Section - Fare 3d.

Between "City" and the intersection of View and Barnard Streets.

Between "City" and the intersection of Pall Mall and Mundy Streets.

Between "City" and the intersection of Mitchell and Mollison Streets.

Between "City" and the intersection of High and Wattle Streets.

City Section - Fare 4d.

Between the intersection of View and Barnard Streets and the intersection of Mitchell and Mollison Streets.

Between the intersection of Pall Mall and Mundy Streets and the intersection of High and Wattle Streets.

Single Section - Fare 6d.

Between "City" and the intersection of Honeysuckle and High Streets.

Between "City" and the intersection of Arnold and McCrae Streets.

Between "City" and the intersection of Miller and Mitchell Streets.

Between "City" and the intersection of Victoria Street and Eaglehawk Road.

Between Honeysuckle Street and the terminus at Golden Square.

Between Arnold Street and the terminus at North Bendigo.

Between Miller Street and the terminus at Quarry Hill.

Between Victoria Street and the intersection of Jackson Street and Eaglehawk Road.

Between Jackson Street and the intersection of Thorpe Street and Mt. Korong Road.

Between Thorpe Street and the terminus at Eaglehawk.

(B) Two Sections - Fare 8d.

Between "City" and the terminus at Golden Square.

Between "City" and the terminus at North Bendigo.

Between "City" and the terminus at Quarry Hill.

Between "City" and the intersection of Jackson Street and Eaglehawk Road.

Between Victoria Street and the intersection of Thorpe Street and Mt. Korong Road.

Between Jackson Street and the terminus at Eaglehawk.

(C) Three Sections - Fare 10d.

Between "City" and the intersection of Thorpe Street and Mt. Korong Road.

Between Victoria Street and the terminus at Eaglehawk.

(D) Four Sections - Fare 1/-d.

Between "City" and the terminus at Eaglehawk.

Children's Fares

The fare for a child under 14 years of age carried on the whole or any part of any one of the said journeys in respect of which the adult fare payable does not exceed 4d. shall be 2d., where the adult fare payable is 6d. or 8d. shall be 3d., where the adult fare payable is 10d. or 1/-d. shall be 5d.

A child under 4 years of age, held in the arms of an adult passenger, shall be carried free of charge.

Pensioners Concession Fares

The fare of any person to whom has been issued a Pensioners† Fare Concession Certificate under the authority of Her Majesty†s Minister of Transport for the State of Victoria and who produces such certificate to the conductor of a tramcar of the Commission during the currency of such certificate —

- (a) in respect of any journey for which the adult fare is not more than 4d. shall be 2d.;
- (b) where the adult fare payable is 6d. or 8d. shall be 3d.,; and
- (c) where the adult fare payable is 10d. or 1/-d. shall be 5d."

3. The foregoing amendments shall come into operation on the first day of August, 1963.
