My best guess is that the horse tram ticket dates from the 1902-1905 era, when the ESCo ran the horse trams. From 1905-1913 Sebas residents had to change trams, so presumably there was a ticket that covered both horse and electric trams. Rather like changing from route 64 to route 5 (Malvern) on Sundays. Of course, I don't have the detailed information to prove it.

A while ago a former Ballarat resident, Max Bennett who now lives in Horsham wrote to us regarding some Ballarat tickets they had.

He dropped in yesterday and showed me the actual tickets, including a Melbourne cable car one. I photographed them and they are shown on the attached file.

They are all strip tickets, with perforations on the top and the bottom. All on light card type paper.

We have a strip of the 1d ones - 12 to a strip with the same number - a 1/- worth. We also have green 2d tickets, 6 to a strip.

The horse tram ticket is interesting, looks like a transistion between the horse tram company and ESCO, or was it used on the Sebas line only.


