INCORPORATION

On 4th October the Ballarat Tramway Preservation Society Limited was incorporated. The Board dissolved the Ballarat Tramway Preservation Society, as provided in the Constitution, on October 12th. The new Company took over the assets and liabilities of the Society from this date.

Applications were made to the Attorney - General of Victoria to obtain a licence to drop the word "Limited" from the Company name. The applications were rejected as it was not considered that the objects of the Company were charitable.

The Company is a Public Company limited by Guarantee. This means that it does not have a share capital but has members who pay an annual subscription in a similar way to an unincorporated association such as the former Ballarat Tramway Preservation Society.

The Memorandum of Association of the Company provides for the limited liability of its members. It is further provided in Clause six of the Memorandum that: -

"Every member of the Society undertakes to contribute to the assets of the Society in the event of its being wound up while he is a member or within one year after he ceases to be a member for payment of the debts and liabilities of the Society contracted before he ceases to be a member, and the costs charges and expenses of winding up and for an adjustment to the rights of contributories among themselves such amount as may be required not exceeding Twenty Dollars (\$20)."

Other provisions in the Memorandum and Articles of Association of the Company closely follow the provisions occitained in the Constitution of the Society. Copies of the Memorandum and Articles of Association will be available from the Secretary on request when printing has been completed.

As the Society has been dissolved and a new Company formed it is necessary for all members of the Society to complete an Application for Membership of the Company.

Members under twenty-one years of age must complete, in addition to the Application for Membership a Guarantee which must also be signed, where indicated, by a Surety (who must be a person aged twen y-one years or over) in the presence of a witness.

The Cuarantee should also have affixed a fifty cent Victorian Duty Stamp.

Both forms are enclosed together with an envelope addressed to the Membership Officer.

No further subscription is payable and your membership of the Company will terminate on the same date as would your for joty membership.

LOLDLIEER WORKER'S INDEMNITY FORMS

As you will recall from the last News Sheet the Board has decided to insist that nobody work for the Society (Now the Company) unless he has signed the required indemnity form.

We enclose an indemnity form addressed to the Company which should be signed by everyone who anticipates working for the Company in any capacity. (Volunteer workers under the age of twenty-one years should have the form signed by a parent or guardian.)

This requirement applies to everyone regardless of whether an indemnity form was signed for the Society.







BALLARAT TOURIST TRAMWAY

The Board has decided that the tramway will be operated under the name "BALLARAT TOURIST TRAMWAY". (B.T.T.) It was considered that the name was less cumbersome and more expressive of our activities than the Company name.

The name Ballarat Tramways was considered but it was decided that this name did not communicate the nature of the tramway sufficiently for use in promotional advertizing as it tends to give the impression that the tramway is simply a service provided by a public transport authority. This name will, however, continue to be used in internal communications.

The name Ballarat Tourist Tramway was registered as a business name, on behalf of the Company, on the 5th October.

A design, incorporating the letters B.T.T., has been prepared. It is similar in style to the Hawthorn Tramways Trust emblem. Transfers, similar to those produced by the A.E.T.M., will be made for sale and use by the Company. Ballarat Tourist Tramway car stickers continue to be available from the Sales Department at 15cents each.
