RE: Macpherson & Kelley Historical Documents

Following on from our phone conversation (8/10/98) I wish to confirm that I have been in contact with the President of the Dandenong & District Historical Society, Mr Ray Carter.

He is in agreement with myself, that we return to your company the "historical documents" that have been in the care of the Historical Society for a certain period of time. We are pleased to hear that Macpherson & Kelley will have the documents properly restored at their expense.

Along with the return of the documents in an Archival Storage box, we are including the "original" quotations for conservation and restoration of the papers, that was originally handled for your company by (the late) Mr Alan Ferguson. These copies can be used for when you have to contact the ORGANISATION that made the first conservation quote if you prefer.

We have also included a pair of white cotten gloves that are to be worn when handling the documents. Please remember that the papers are considered "precious" and until they have been properly conserved they should NOT be handle to often.

Conservation of the historical documents may take a while to complete. Perhaps your company could have a few of the more important papers preserved first for when you move to Scott St, and then continue on with rest at a later date. The decision is up to Macpherson & Kelley, once the documents are back in the company's care.

The papers can be stored in a cool, dark, safe, and secure atmosphere. I am quite sure you know where to keep them for future reference.

I have one request to ask of Macpherson & Kelley. It is that, when you display the conserved/preserved documents that you acknowledge the Dandenong & District Historical Society for their temporary "caretaking" of the historical documents.

I hope that everything goes well with the move to the Scott St premises and perhaps in the future the members of the Dandenong & District Historical Society can be invited to view the exhibited documents.
