SUTTON INSISTED THAT HE GAVE THE RIGHT CALL TO "CLOSE i COOK FOODS".

RAY CHRISTY. RAY'S EMAIL WAS NOT REPORTED TO i COOK'S FOOD BEFORE THE CLOSURE OF FACTORY. IT SAID JEAN PAINTER (PATIENT) AT SANDWICHES PREPARED IN THE KNOX PTE HOSPITAL KITCHEN. THE REPORT ARRIVED SIX HOURS LATER

CLOSURE OF i COOK.

BRETT SUTTON HAD TO ACT IMMEDIATELY OWING TO THE 7000 WEEKLY MEALS BEING DISTRIBUTED — IT COULD CAUSE A LARGE FATAL LISTERIA OUTBREAKS.

IN QUERY 2020. BY BRETT SUTTON STATED WRONGLY THAT i COOK WAS THE SOLE SUPPLIER TO KNOX PTE HOSPITAL — THERE WAS 5 OTHERS

CLOSURE WAS BASED ON 4 FOOD SAMPLES FROM i COOK FACTORY AND PATIENTS LISTERIA STAIN AND SAMPLES WERE **NOT** FOUND ELSEWHERE.

SINCE THE CLOSURE. 13th - 23rd JANUARY THE PATIENT ATE i COOK SANDWICHES. BUT AFTER 25th JANUARY ON A SOFT FOOD DIET. — THERE WAS NO OTHER OUTBREAKS AT THE HOSPITAL — HOSPITAL KITCHEN WAS NOT INVESTIGATED

SUTTON'S STATEMENT — GREATER DANDENONG INSPECTORS HAD FOUND

i COOK STAFF AND SUPERVISORS HAD LITTLE UNDERSTANDING OF SAFE FOOD PRACTICES.

i COOK. STATE 14 DAY INCUBATION PERIOD FOR LISTERIOSIS COULD MEAN THE PATIENT CONTRACTED THE POISONING BEFORE HER HOSPITALISATION

ELIZABETH GARLICK. ENVIRONMENT HEALTH OFFICER FOR DANDENONG.

GARLICK DENIED PLANTING THE "SLUG" AND THAT

KIM ROGERSON. FORMER. HEALTH INSPECTOR FOR DANDENONG KIM ROGERSON HAD EDITED OUT TISSUE FROM THE SLUG PHOTO

GARLICK WAS SENT TO INVESTIGATE THE POSSIBLE SOURCES OF CONTAMINATION.

STATE THAT MOTHER DID EAT i COOK SANDWICHES. SHE WAS ADMITTED TO HOSPITAL WITH GASTROENTERITIS. AND ATE NORMAL FOOD DIET UNTIL - 23RD JANUARY SHE WAS RE ADMITTED WITH A MORE SEVERE ILLNESS ON 25TH JANUARY 2019 AND ATE SOFT FOOD ONLY PREPARED AT HOSPITAL KITCHEN. SHE DIED IN GREAT DISTRESS AS SHE DETERIORATED.

D'NONG COUNCIL JOHN BENNIE. SAID i COOK WAS NOT CLOSED DUE TO THE DEATH AT KNOX. KNOX FOOD INSPECTOR DOUBTED THAT i COOK'S FOOD WAS EATEN BY THE PATIENT. NO CHARGE ON HOSPITAL IN RESPECT TO THE SANDWICHES - THERE WAS 96 CHARGES ON i COOK'S FOOD SAFETY CHECKS FOUND BY INSPECTORS (ELIZABETH GARLICK AND LEANNE JOHNSON) - DEFICIENTS CONFIRMED BY D'NONG OF HEALTH AND ATTESTED BY SUTTON

KIM ROGERSON - EX INSPECTOR KIM ROGERSON TOOK SWABS OF FOOD FROM THE KITCHEN IN EARLY FEBRUARY 2020 - SHE WAS PRESSURED TO LIE. AND ALTER HER STATEMENT TO AID THE PROSECUTION BENNIE. (CEO COUNCIL) SAID. NO EVIDENCE TO HER. STATEMENT IS ROGERSON'S - THE LOW LEVEL OF LISTERIA WAS SAFE FORMING NO CHARGES.
