### re "GINGER MEGGS"

I wish to acknowledge your letter of November 29, and to confirm our telephone conversation of yesterday. We are pleased that it appears possible that we shall be able to negotiate with you for the rights of "Ginger Meggs" for television adaptation, and wish to submit the following:

1. It will be necessary for us to produce a pilot programme, both to enable your company to be satisfied that our production is up to standard, and also to enable Crawford Productions to assess the market possibilities of such a feature. We anticipate that the cost of production of the pilot will be in the nature of £500, and as we shall have this investment in the project at this stage, we should appreciate your giving us an option of six months nn which to produce the pilot, submit it to Australian Consolidated Press Ltd., and also to test the market possibilities of our television version of "Ginger Meggs".

2. By the nature of the animated technique which we are using, it would not be possible for us to use the services of your artist, Mr. Ron Vivian. I think I explained this to you in detail on the "phone.

3. I assume the price of £20 per five-minute episode would be for Australasian rights. I should apprechate your granting us the rights for, say, seven years, to enable us fully to exploit the Australasian market for the series.

Should you be discussing this matter with Sir Frank Packer, I should be glad if you would convey to him my kind regards. He exercised a kindly influence over our drama production, "Consider Your Verdict", when it was played on his station, TCN Channel 9.


