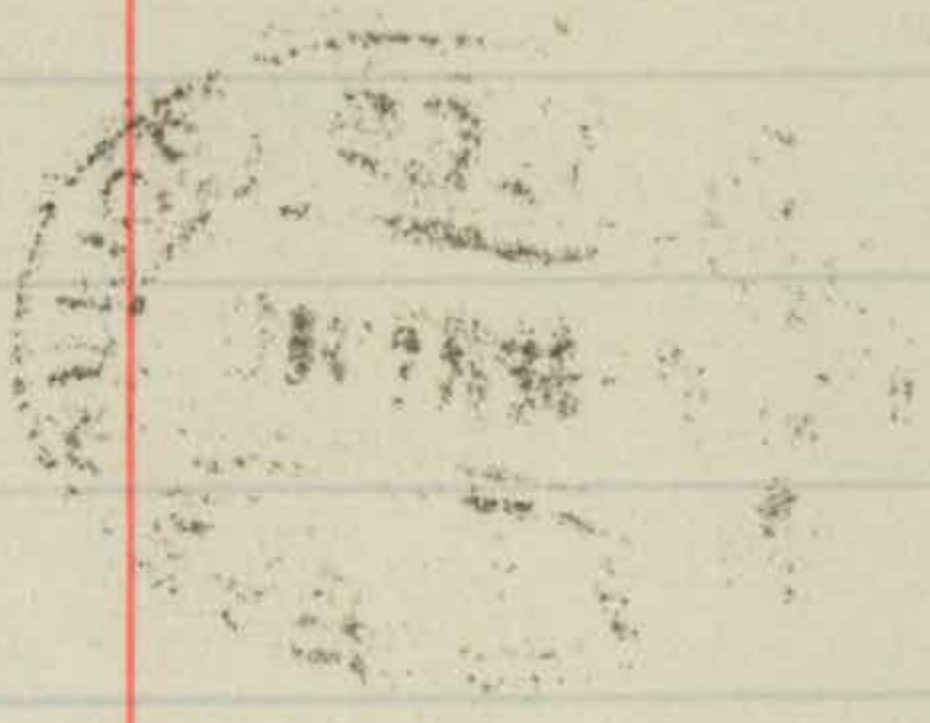

2. THAT I am 30 years of age and was born at Christchurch New
Zealand and am domiciled in the State of Victoria.
3. THE said Respondent is 31 years of age or thereabouts and
was born in Victoria and is domiciled in the said State of Victoria.
4. BEFORE marriage I was a Bachelor and a Theological Student
and after marriage I followed the occupation of a Missionary and
Superintendent of Technical Schools in India.
5. THE said Respondent before marriage was a Spinster and
earned her livelihood as a Shop Assistant and after marriage was
maintained and supported by me.
6. IMMEDIATELY after the said ceremony of marriage Respondent
and I went to reside at Mymensingh East Bengal India where we remained
for a period of about 4 months when we moved to Faridpur East Bengal

aforesaid where we resided until the month of December 1918 when the Respondent returned to Melbourne and went to reside with her parents.

7. FOR a period of 2 years prior to the Respondent leaving for Melbourne as aforesaid although living in the same Bungalow we lived entirely apart owing to the circumstances mentioned in Paragraph 9 hereof.

11. SAVE as aforesaid there have been no separation or separations between me and the said Respondent.

12. I distinctly and unequivocally deny all collusion or connivance past or present direct or indirect with the Respondent.

were correct and that she would not submit herself to examination. I then told her that the result of such a course might be that the Court would decree that the marriage between herself and the -- Petitioner was null and void without her being heard but that she could at any time before the Decree was pronounced change her mind and appear and give evidence before the Court. She replied that she thought under the circumstances that it was better to let the case go on. Her brother who was present then asked whether the Petitioner was going to make any allowance. I replied that no arrangement of any kind could be made at all and asked whether it would not be as well that Respondent should see a Solicitor on the matter and to this Respondent simply replied "No." They then withdrew.
