A SQUADRON 8/13 VMR SUPPORT TO ARMY DISPLAY AND FAIR 88

Reference:

- A. ADAP 88 Instruction dated Aug 87

Introduction

1. A Sqn 8/13 VMR Light Horse Troop will provide support to ADAP 88 at Watsonia during the period 19 - 21 Feb 88.

Aim

2. The aim of this instruction is to detail pers to task, and to outline the admin requirements for this activity.

Form of Support

3. The Light horse Troop will perform the following displays:
- a. Static Display, and
 - b. Tent Pegging display.

Key Personnel

4. CAPT R.N. Morrison is appointed Officer in Charge Light Horse Tp Display.
5. CPL H.K. Morris is appointed acting Tp Sgt of the Light Horse Tp. He is responsible for the transport, and care of the horses.
6. CPL A. Florent is appointed Arena Master. He is responsible for the setting up of the Arena in conjunction with 5th Coy, and for maintaining the peg score during the competition.

Nominal Roll

7. A nominal roll is shown at Annex A to this instruction.

Training

8. Training for the Light Horse Tp display will be conducted at Albury during the period 6 - 7 Feb 88.

Transport

9. Transport NCO is to arrange tpt in accordance with Tpt requests shown at Annex B to this instruction.

Accommodation

10. Horses will be accommodated at Albury over night 6 Feb 88, and at Watsonia over night 19 - 20 Feb 88. Tp Sgt is to supervise a picquet over those nights.

11. Pers will be accommodated at Albury over night 6 Feb 88, and in their respective lines at Watsonia 19 - 20 Feb 88. Own bedding is to be taken.

Rations

12. Rations will be fresh. Members will be responsible for cooking their own rations during the period 6 - 7 Feb 88, and will be rationed for in their respective messes at Watsonia during the period 19 - 21 Feb 88. Chief Clerk 8/13 WIR is to forward S997's to Admin Offr ADAP 88 NED 29 Jan 88 in accordance with Annex A.

Fodder

13. Sufficient fodder is to be purchased from Doug Bydes Produce to feed 6 horses for 5 days.

14. CAPT Morrison is to forward the account for fodder to Admin Offr ADAP 88 for payment.

Medical

15. A Section Medical Kit will be carried on each vehicle for the treatment of minor injuries.

16. Any serious injury will be evacuated through the Watsonia RAF.

Veterinary

17. Veterinary services will be requested from the nearest Veterinary Clinic when required, on a member to pay basis.

Stores

18. SQMS 6/13 WMR is to be prepared to issue stores NLT 1930 hrs 5 Feb 88.

19. Stores request is to be attached as Annex C to this instruction.

Weapons

20. CPL Morris is to ensure that the Humane Destroyer, and sufficient ammunition accompanies the horse transport. He is responsible for the security of the weapons, and ammunition on issue to the Light Horse Tp during the activity.

Dress

21. The following orders of dress will apply:

- a. Movement of horses - Work Dress
- b. Training - Stable Dress
- c. Displays - Ceremonial Dress Summer
- d. Off Duty - Smart Civilian Attire

Commentary

22. CAPT Morrison is to provide a running commentary during the display.

Conclusion

23. This annual participation at the 3RD Army Display and Fair, affords the Light Horse Tp the opportunity to further the aims of the Troop, and provides an excellent Public Relations exercise to enhance the image of the Sqn.

24. Each member is expected to conduct himself in keeping with the fine traditions of the WMR, and the highest standard of turnout is mandatory.
