## FOR THE ADULT DEAF AND DUMB.

The **Adult Deaf and Dumb Society of Victoria** provides a special Institute for the **Adult Deaf and Dumb**, known as **The Adult Deaf Mute Centre** (32-34 Flinders-street, Melbourne).

Every effort is made to provide these doubly handicapped people—at our **One** Institution—with the same advantages as are enjoyed by hearing and speaking people in many associations.

The headquarters of the Society contain a Church, Social and Lecture Hall, Classrooms, Billiard Room, Library, Offices, etc. Here services, lectures and classes are regularly conducted in the language of the deaf and dumb by expert instructors. There are frequent socials and entertainments; also here the Deaf Lacrosse, Cricket, Tennis and Rambling Clubs hold their meetings.

We have an officer on duty from 9 a.m. to 10 p.m. daily to assist in our activities of the Employment Bureau and Relief Agency. The Society also publishes its own newspaper. The mere fact of being deaf and dumb entitles all so afflicted to these advantages. It is open to all denominations.

## FOR THE AGED, INFIRM AND BLIND DEAF AND DUMB.

There is a comfortable **Home** beautifully situated at Blackburn. For those who are **Mentally Defective**, as well as deaf and dumb, there is a **Training Farm** connected with this **Home**. This is another activity of the Adult Deaf and Dumb Society.

We believe there are many more in the State bearing these terrible afflictions, the relations and friends of whom have never heard of our **Home**.

# THIRTY-NINTH ANNUAL REPORT OF THE Adult Deaf and Dumb Society OF VICTORIA (INCORPORATED) MARCH 31st, 1923

It is with great satisfaction and feelings of thankfulness that the General Board submit their 39th Annual Report.

The Deaf and Dumb people continue to show ever increasing appreciation of the many benefits which the Board are enabled to provide, through the kindly interest and contributions of our generous public. Everything possible is done to improve the physical, mental, moral and spiritual well-being of our Deaf Citizens. Any suggestion made by the deaf that may in any way improve their condition or brighten their lives with wholesome pleasure will always receive the sympathetic consideration of the Committee.

### THE CHURCH FOR THE DEAF.

To preach the Gospel of our Lord Jesus Christ to the deaf in their own language is the first object. The Church occupies the main part of our Centre, and is the pivot upon which the whole of the work revolves. At the Conference of Representatives of Adult Deaf and Dumb Societies of Australia, held in Sydney in October last, the question of a special form of Service and Hymnal for the Deaf and Dumb was discussed, and the Rev. A. G. Cutts (Anglican Clergyman and Organising Secretary of the N.S.W. Adult Deaf and Dumb Society's Building Campaign) said: "I should like to say, Mr. Chairman, that no one could desire a more reverent service than was conducted morning and evening in the Adult Deaf and Dumb Church in Melbourne. It was my privilege to be present at that service. In the morning there was a celebration of Holy Communion, and one might easily have supposed that they were in St. Paul's Cathedral. In the evening the service was so entirely simplified, and in a common-sense way adapted to the congregation, that one felt that everyone in the Church was worshipping. If you,

sir, can, throughout the States, in this particularly difficult way, propose a service in which everybody can join, as they do in Melbourne, we shall considerably lift the tone as we desire of the spiritual life of the deaf. I got on my feet to say that in Melbourne I think there is the ideal both in the way hymns are used and in the way the service is conducted." To this high appreciation of the form of worship and reverence of the deaf worshippers it is only necessary to add that these religious observances continue to draw the largest attendances of all the fixed gatherings.

#### EMPLOYMENT OF THE DEAF.

One outstanding improvement is the general advancement of the deaf. The teaching and training of our Society has been largely instrumental in bringing it about, and it is a fact that seldom is a normal deaf mute out of employment more than a few days. By their industry and skill they have won their way into favor with employers of labour. Not many years ago we had to deplore that year after year the question of finding work for unemployed deaf and dumb was a difficult problem. This problem has now been solved.

#### THE CENTRE.

All the organisations of the Society are in a progressive state. Our Central activities are:—The Scripture and Educational Classes, Lectures and Socials, the Men's and Women's Guilds, Workers' Club, Lacrosse, Cricket, and Rambling Clubs, Library, Bank, and our Deaf Newspaper. Particulars of all these will be found in the extracts from the Deaf Committee's Report.

#### RELIEF AGENCY.

Thanks to the complete provision made for indigent cases at our Home at Blackburn, our Society is but seldom called upon to give monetary assistance. At present there is but one case upon our books (a deaf mute widow and infant) in receipt of regular assistance. Her hearing and speaking husband was accidentally killed at a railway crossing. The Moorabbin Progress Association raised about £300 towards the purchase of a house, and our Committee has undertaken to provide a weekly grant sufficient for the maintenance of herself and child until such time as she is able to earn her own living.

#### DEAF CHILDREN OF SCHOOL AGE AND ISOLATED ADULTS.

Our Country Collectors from time to time meet with deaf mute adults and deaf mute children who are without education, notwithstanding the Compulsory

Education Act. Unless these children are educated they will not, later, be competent to maintain themselves, becoming a burden on the community and their own lives will be a distressing blank. In a recent publicity campaign, with the aim of finding as many as possible of these children, the Queensland Society were successful in locating no less than 76 deaf and dumb as well as blind children. Our society is, at present, embarking upon an effort to gather in deaf mute adults and deaf mute children, also those who through mental infirmity or other causes are unable to maintain themselves.

#### TOY CAMPAIGN FOR THE HEARING POOR.

The Members of our Centre take a lively interest in philanthropic efforts, and their contributions to hospital and other funds is evidence of this interest. They have, on occasions, initiated special efforts on behalf of deserving causes. Last year they entered upon a Toy Campaign, appealing for discarded toys, which they undertook to mend, renovate and distribute amongst the hospitals and to the homes of the poor. In reply to their appeal, some thousands of toys were received, and for some six weeks the Centre was a hospital for toys, men and women devoting practically the whole of their evenings to repairing, sorting and packing the toys, which ultimately brought pleasure to thousands of children who are not deaf and dumb.

#### RECREATION GROUND.

For years the Deaf Cricket and Lacrosse Clubs of the Society have experienced great difficulty in obtaining the use of suitable grounds for their games, and the Tennis Club has never yet been able to secure the regular use of a court. Upon representations being made to the Committee by the younger members of the Society, it was decided to grant the use of that part of the Blackburn Estate known as "The Park" for a Recreation Ground for the Deaf and Dumb, conditionally that they raised the money to cover the cost of the clearing and levelling and erection of dressing sheds. This our young deaf people undertook to do, and some four acres of the outer Park land have been cleared of scrub-timber and levelled, part by paid labour and part by working bees of our deaf young men. The Committee are satisfied that the new grounds will prove to be a great asset in helping to keep the young people together, providing them with opportunities for healthy recreation. There are already two Lacrosse and two Cricket Teams, and a Tennis Club connected with the Society. Other sports will be encouraged, such as running, swimming, etc.



### UNFINISHED BUILDING.

Now that the Blackburn Home for the less fortunate of our charge—the section of the deaf and dumb who, by reason of other infirmities, have to be housed, nursed and cared for—has been completed the General Board may turn its attention to the much-needed additions at the Centre. The Committee still hope to be able to procure a more suitable site; but should they fail to do so additions will be made to the present building.

Our President, Dr. J. F. Mackeddie, has left for Europe on research work. The Committee, on behalf of the Society, conveyed to Dr. and Mrs. Mackeddie best wishes for a pleasant and profitable trip.

### THE HOME AT BLACKBURN.

Everything is done at the Home to bring as much sunshine into the lives of the sorely handicapped inmates as conditions will allow. Members of the Centre, under the auspices of the Deaf Workers' Club, visit the blind deaf men frequently, telling them the news of the day. Those of the mental cases able to derive pleasure from the Pictures are permitted to attend those entertainments. Through the kind offices of Mr. Evans, and the generosity of the Directors of the Bay Steamers Ltd., the inmates and staff of the Home, together with the women and children connected with the Centre—one hundred in all—enjoyed a trip down the Bay, and the following ladies and gentlemen paid the cost of dinner and other refreshments on board:—Messrs. A. Whybrow, H. V. McKay, MacRobertson, Jas. Dyer, G. Doery, W. M. McPherson, Mrs. Payne, Mrs. T. Kitchen, Miss E. J. Hearn, and Miss Grimwade. The Home provided tea. The inmates of the Home also attended an afternoon performance of the pantomime, "Forty Thieves," at the Theatre Royal, by invitation of the Manager, Mr. D. McGreig. And the members of the Christian Endeavour Society gave the Home a surprise visit, bringing all kinds of dainties, cakes, fruit, sweets, books, etc. To these ladies and gentlemen the Committee tender grateful thanks.

Since the establishment of the Home, nearly fourteen years ago, eighty-eight persons have benefited by its provisions, many of whom are now earning their own livelihood. During the past year eight persons were received into the Home, two temporarily, one left to go to employment, and one—a blind deaf mute—died at the age of sixty-four. Of the present inmates—thirty-one in all—few are able to do much in the way of productive labour, the majority being mental cases, aged, infirm, and blind, deaf and dumb, and need constant personal attention and care.

Occupation of mind and body are essential to the health, training and happiness of the mentally afflicted deaf, whether productive or not. And as the eye and hand are the only means by which instruction can be imparted, the appeal must be made through the eye, hence the choice of the cultivation of flowers as an occupation, and notwithstanding the mental and physical defects the Society's experts never fail in getting practically all to at least take an interest in the work.

Last year the Committee were fortunate in securing the services of Mr. George Brown, ex-curator of the Melbourne Public Parks and Gardens, who is giving agricultural and horticultural instruction to the inmates.

Their care and training are in the hands of the Principal of the Society, the Matron of the Home, Mr. Douglas Abraham (son of the Principal), and Mr. A. McLellan (deaf), all of whom are experts in this particular work.

### HOME GROUNDS.

The laying out of the grounds in front of the Blackburn Home is well advanced. The drive from Central Road has been constructed, lawns formed, and shrubberies planted. Weather conditions being favourable, this work will be proceeded with; also the grounds around the Hospital Cottage will be treated in like manner.

### VISITATION.

The Committee have lost the valuable services of Miss H. Dow, which were much appreciated by the parents of our deaf and dumb girls. She resigned for health reasons, but continues to render honorary services at the Centre.

### CONFERENCES.

At the Conference of Workers amongst the Adult Deaf, held in Sydney, last October, this Society was represented by Messrs. Ernest J. D. Abraham (Principal), R. H. Luff and J. M. Johnston, and Messrs. W. A. Paterson, J. M. Johnston, and F. Rees represented the Society at the Sports Conference held in Adelaide in December.

A Congress of the Deaf and Dumb of Australasia is to be held in Melbourne in December-January, 1923-24.

The Committee record with deep regret the demise of the following members:—Mr. G. W. McLaurin, of St. Kilda, on June 20th, 1922; Mr. J. Dempsey, of Northcote, on June 25th, 1922; Mr. Sellen, of Moorabbin, on July 5th, 1922; Mr. Robert Brown (inmate of our Blackburn Home) on September 26th, 1922; Mr. A. Pearce, of Beech Forest, on December 31st, 1922.

Your Committee tendered the relations in all cases the sincere sympathy of the congregation in their sad bereavement.

In conclusion, the Committee desire to express their appreciation of the confidence shown in them by the congregation, and trust the coming year will prove that good fellowship and unity are ever to be found amongst us. We also desire to offer our most grateful thanks to our Heavenly Father for all His loving kindness and protecting care.

## Summary of the Proceedings of the Conference

of Representatives of Boards of Management, Superintendent of the Adult Deaf and Dumb Societies of Australia, held in Sydney, October 1922.

(Compiled by Mr. A. W. Cox, Hon. Sec. to the Conference).

### THE WORDS "ASYLUM" AND "INSTITUTION."

The first subject brought under the notice of the members was the use of the words "Asylum" and "Institution" in connection with the schools for the deaf. It was felt that the word "Asylum" was especially objectionable, and gave the public a wrong impression with regard to the mentality of the deaf. The following resolution was carried:—"That this Conference respectfully urges upon the Boards of Schools for the Deaf throughout the Commonwealth (in the interests of their ex-pupils) to discourage the use of the words 'Asylum' or 'Institution' on the part of their patrons and the public generally, and to substitute the word 'School' or 'Residential School for the Deaf'; for so long as the educational establishments for the deaf are named 'Asylums,' 'Institutions,' or 'Institutes,' thus making a distinction and difference between them and schools for normal children, so long will the public have a wrong impression of the mental condition of the Deaf."

### MOTOR LICENSES FOR THE DEAF.

The discussion on this question resulted in the following resolution:—"That this Conference deems it unwise to take action, and considers that the matter should be left in the hands of the Superintendents to deal with individual cases as they may arise."

### ADULT INSTITUTES.

What conveniences should be provided? Mr. Abraham outlined what he thought was a complete building scheme for an Institute for the Adult Deaf. His proposal embodied the following:—A chapel or church, a social hall, class room, men's parlour, smoke room, and conveniences, ladies' parlour, etc., gymnasium, library and reading room, billiard room, office, kitchen (well appointed), bedrooms for apprentices, breakfast room, bathrooms, apartments for caretaker, board room, and general offices.



**HOSTEL ACCOMMODATION FOR THE DEAF.**

It was generally felt that accommodation should be provided for both sexes in the Society's buildings, that the females should have the same advantages as the males in this respect, and it was thought that the buildings should be so arranged as to provide a church, social hall, and administrative offices in the centre, and that hostel accommodation be made on either side of them so that the sexes should be separated at night.

It was unanimously resolved that the scheme outlined by Mr. Abraham be recommended as a complete institute building for the Adult Deaf and Dumb; also a motion recommending the accommodation arrangement to all Adult Deaf and Dumb Societies was carried.

**RECORD OF DEAF MUTES.**

The necessity of linking up the deaf pupils with the Adult Societies when leaving school was pointed out. Instances were given of the deaf leaving school and going back to the country, where they were often lost sight of altogether. It was agreed that a register containing the names and particulars of all deaf people should be kept in each State, and that a deaf person leaving one State for another should carry a letter of introduction. To bring this about it was recommended that the various Adult Deaf Societies should get into touch with the State Deaf School with the view of getting a record of all pupils who were shortly leaving, and to use every other possible means to obtain a complete record of the deaf in each State.

**RELATION OF DEAF SCHOOLS TO STATE SCHOOL SYSTEMS.**

It was agreed that every means should be employed to raise the standard of education for the deaf, and the conference recommended that steps be taken in each State to bring the deaf children of the community under the Compulsory Education Clause, and, therefore, under the supervision of the Department of Education.

**THE RELATION OF DEAF SCHOOLS TO ADULT DEAF SOCIETIES.**

The following resolution was carried unanimously:—  
"That this conference desires the most friendly co-operation between the Society and School authorities in all the States." The hope was expressed that, in future conferences, representatives from schools as well as Societies would meet together.

**TECHNICAL CLASSES FOR THE DEAF.**

It was recommended to all Adult Deaf Societies to take advantage of State Technical Schools and form classes in such branches of technical training as would be beneficial to the deaf, and that the Societies should supply interpreters to assist the instructors.

**FORM OF SERVICE AND HYMNAL FOR THE DEAF.**

The discussion on this subject resulted in the following resolutions being carried:—

1. "That it be a recommendation to the Societies in the various States to elect a Committee, with the superintendent as convenor, to make a choice of favourite hymns, send them to the other States, and then have them placed before a final Selection Committee."

2. "That Superintendents in the various States draw up a form of service and submit same to the deaf congregations for their approval."

**INTERMARRIAGE OF THE DEAF.**

Mr. Abraham was requested to make further investigations along the lines of medical science and get information that would be helpful, and distribute it amongst the deaf through the Societies.

**EMPLOYMENT OF THE DEAF.**

It was resolved that Messrs. Luff, Booth, Showell, and Cox be requested to prepare a list of the different trades and professions in which the deaf are engaged in their respective States, and distribute them amongst the representatives of all the States.

**TRANSFER OF MEMBERS FROM ONE STATE TO ANOTHER.**

Messrs. Abraham and Cox were requested to prepare a form of transfer that could be used when a deaf person is moving from one State to another.

**DEAF COMMITTEES.**

It was recommended that only subscribing members be allowed to vote at the election of the Deaf Committee and their Officers; and that all money subscribed by the deaf (excepting for clubs under the control of the Deaf Committees) should go through the funds of the Society. The Superintendent or Missionary to be ex officio chairman of the Committee.

**MANAGEMENT OF FUNDS.**

Delegates gave reports of the various methods employed in each State in collecting subscriptions, and the reports were received.

## IMMIGRATION RESTRICTIONS OVERSEAS AND INTERSTATE.

Information on this subject was needed, and the matter was delegated to Messrs. Abraham and Cox, who would report later on to the various Societies the result of their inquiries.

## AUSTRALASIAN DEAF AND DUMB ASSOCIATION.

The objects of this Association are:—

- (1) To unite the deaf and dumb and create interest in their welfare.
- (2) To advance and protect their interests and to raise their social status.
- (3) And to give practical illustrations of the capabilities of the deaf.

This Association has two branches, the Victorian and the Queensland. The branches in South Australia and New South Wales had become defunct. The following resolution was carried:—"That the State Societies be recommended to obtain data with the view of—(1) Re-forming the A.D. and D.A.; or (2) the creation of a Federal body of State Societies; a report to be given on this and any other matters relating to the deaf to a Conference to be held in 1923.

## INTERSTATE DEAF CRICKET

And other sports were discussed, and it was resolved that we strongly urge the clubs in each State to have the competition for the Abraham Shield revived.

## INSURANCE.

It was deemed advisable that the deaf should insure their lives.

## From Teacher to Missioner.

(Mr. Story is the Author of several Educational works and is an authority on the Education of the Deaf).

At a recent meeting of the Council of British Church Missioners to the Deaf, held at the School for the Deaf, Stoke-on-Trent, Mr. A. J. Story (Headmaster) delivered an inspiring address to the members present. Mr. Story first indicated satisfaction that the Council should have accepted the invitation to hold the meeting in that Institution, in that it afforded the Committee and himself an opportunity which they gladly seized, of expressing in a practical way their sympathy with the work in which the individual members of the Council were engaged.

Mr. Story then defined education as a preparation for life, and claimed that if this were so, education itself must be life. Life was complex in its characteristics, and its highest realisation depended upon the perfect blending of the four-fold nature of the individual—physical, mental, moral and spiritual. There was a tendency here and there to disturb this essential balance and to anticipate, in the cases of deaf children, vocational success for which the full development of their various powers was a pre-requisite. Education did not consist of excellence in this or that subject, whether intellectual or manual, but in the harmonious development of the whole nature, of which, after all, character was the most important expression. This all-round development was the concern of the teachers.

Children passed from the care of the teachers to that of the missioners.

As education, being life, should necessarily continue throughout life and could never be complete until it was consummated in the Life of the Hereafter, he regarded those present as teachers, whose work should follow upon that of those who ministered to the deaf in the schools. The work of missioners was, therefore, an intensely serious one, equal in importance to that of the schools, even if it were not greater. It included features in practical life—intellectual, industrial, social, moral and religious—which the schools do little more

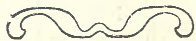

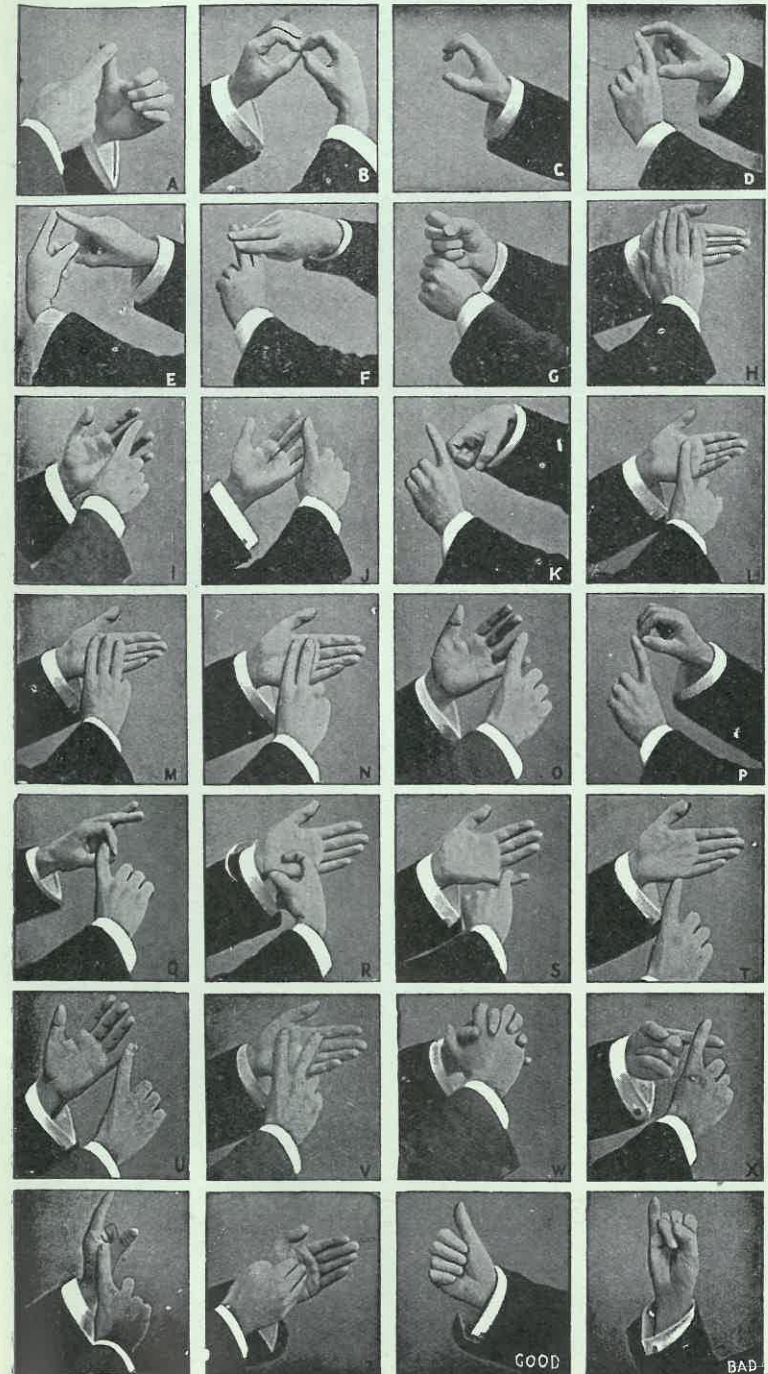

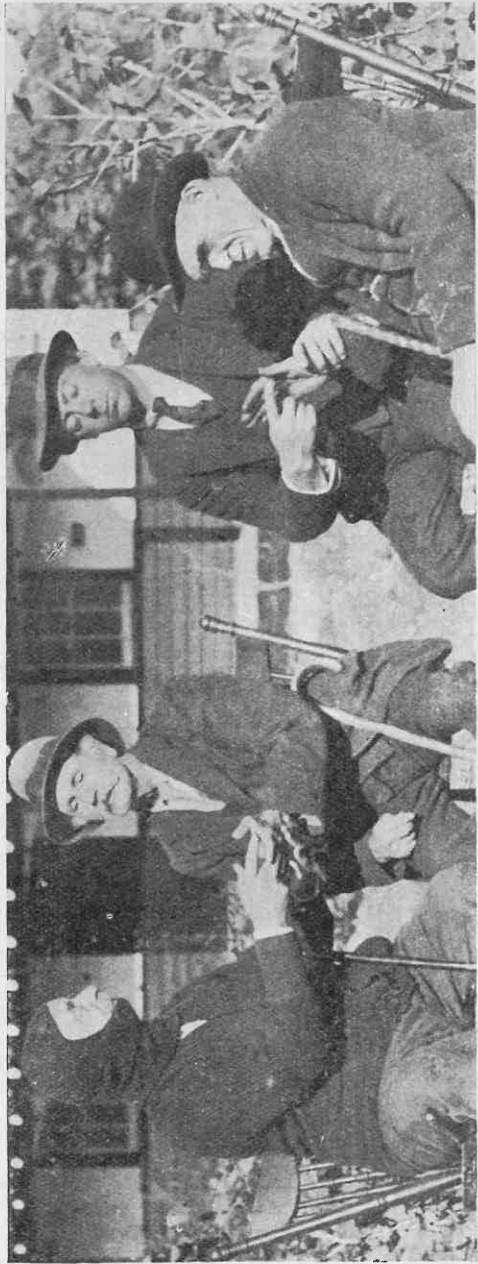
