PROPOSED **RE-SUBDIVISION OF** WARD BOUNDARIES IN CITY OF CAULFIELD

The Town Hall is to stay and those who made written submissions on the subject have been invited to speak at a special meeting of Council early next month.

The Caulfield City Council made these decisions at its fortnightly meeting held on Tuesday, July 13.

The Mayor, Councillor S B. Taylor, said more than 300 written submssions had been received by Council following the announcement last March of the proposed Civic Centre.

"After careful consideration of these thoughtful comments we have decided to retain the Town Hall and hold a hearing at a Special Meeting of Council at which people who previously made written submissions can have the opportunity of further communicating their views to Council on the best, most practical and economic uses to which the building can be put."

"Letters have already been sent to those who previously made submissions inviting them to attend the hearing if they wish.

"The hearing will be held on Monday, August 2, commencing at 2.00 p.m. in the Council Chamber and going through until 9.00 p.m.",

said Cr Taylor.
"The press will be invited

to attend this hearing.
"It is to be hoped this course of action decided by Council is welcomed by the majority of residents," the Mayor said.

The General Purposes Committee through its Lady Chairman, Cr Nancy Needham, proposed the resolution for the retention of the Town Hall and for the need for a further public hearing on the matter.

Cr Needham said after the Council Meeting that it should be made clear that the effective use of the Town Hall as a community venue could only be achieved if new administrative offices are built and Council staff are moved out of the Town Hall buildings which they present-

ly occupy.
She said that half the staff, together with the Caulfield Citizens Advice Bureau and the Caulfield Community Service are working in temporary offices placed in Centenary Hall; while others work in both sub-standard and inefficient working con-

The Mayor said, "The decision taken on Tuesday (July 13) now provides for further community participation in the decision-making process of Government." Local

The National Heart Foundation is holding its annual "Heart Sunday Appeal" on Sunday, 1st August.

The President of the Caulfield Appeal Commit-tee, Cr Brian Rudzki, said that heart disease was a major killer in Australian Society.

He said that the National Heart Foundation was presently spending \$1.5 million annually to combat the incidence and effects of heart

"The \$1.5 million is funded almost entirely by donations, and is spent on programmes for research, professional and community education, and rehabilitation of heart patients," Cr Rudzki said.

Figures published by the

Australian Bureau of Statistics showed that in 1974, over 62,000 Australians died from all forms of heart disease.

"The death rate from coronary heart disease has been falling slightly since 1967, and I'm sure the programmes carried out by the National Heart Foundation are a con-tributing factor," said Cr

"However, the message we are trying to get across, is that the Heart Foundation needs more funds to keep its important work going.

"The Heart Sunday Appeal is the National Heart Foundation's principal means of gathering funds, and I'm sure the people of Caulfield will give generously when a collector calls this Sunday," he said.

"Previously, vehicles from Alma Road were actually required to travel against the

"Traffic from Hawthorn Road also adds greatly to the congestion, and this together with the overall increase in traffic meant that at peak hours there was considerable danger to motorists attempting such a crossing.

"We as a Council decided that the best way of reducing the danger and the congestion, was to install a traffic island at the initial and the major

Caulfield City Manager, Mr Kerry Wilson said that letters had been sent to local residents in Alma Road regarding the traffic island.

"We will be watching the intersection very closely over the next six months to see what affect this traffic island will have on the flow of traffic, and Council has invited local residents to submit any comments and suggestions they may have during this time," Mr Wilson said.

CHILD SERVICES COMMITTEE

Caulfield Council is presently examining the possibility of creating a Community Committee on Children's Health Services to provide community input into the planning and development of future Infant Welfare Centres within the City of Caulfield.

Council is faced with the need for extensive renovations to some of the existing Infant Welfare Centres, especially the Carnegie Centre in

Truganini Road.
The Committee would be examining the present and future needs for child health services, and looking at ways that Infant Welfare Centres can meet these needs.

One alternative already being put forward is that the Infant Welfare Centres should be trans-formed into Family Care Centres, offering total child health care and supervision.

Reports are presently being drafted for Council on the means of setting up such a Committee within

the near future.

CAR PARKING POLICY

A Car Parking Policy is presently being prepared on the future provision and construction of car parks throughout the municipality.

A draft of the Car Parking is nearing completion. Caulfield Council in-tends to send copies of the completed draft to various interested community groups to get their com-ments and suggestions

before drawing up a final Car Parking Policy. PRE - ESTIMATES FOR 1976/77

Council is currently preparing pre-estimates for expenditure during the 1976/77 financial year.

(Caulfield Council's financial year runs from the 1st of October to the 31st September)
Basic objectives have

been set by Council, and the main emphasis is on maintenance and cleanliness throughout the municipality.

The newer services introduced in the Recreation and Culture Department, and the Social Development Department will be strengthened and continued.

Forecast inflation trends for the next financial year indicate an inflation rate of 15%, and the basic aim of Caulfield Council will be to contain the rate increases to a minimum.

FEDERALISM POLICY Latest news is that Vic-

torian Local Government will receive in the vicinity of \$35 million in the next financial year.

This increase in Local grants comes as a result of the implementation of the Federalism Policy by the Federal Government. The \$35 million will be

distributed to Victorian Councils on a population and needs basis.

On a population basis, the City of Caulfield can expect to receive \$271,000. The distribution of funds according to a needs basis have not yet been determined.

However, taking into account a needs basis grant, Caulfield City's total grant from the Federal Government is anticipated to be at least double last year's grant of \$165,000. RE-VALUATION OF

**PROPERTIES** 

The City Valuers Department of the City of Caulfield is presently carrying out the revaluation of properties within the

city.
Valuations of properties
provides Caulfield Council with an equitable rating base from which to derive its expenditure to meet the estimated budget for the

coming financial year.
The Local Government Act sets out that the revaluation of properties must be carried out every four years.

The revaluation of properties does not directly mean that rates will increase as a result.

Candidates wishing to nominate for election must do so by 4.00 p.m. on Monday, August 9th. If more than one nomination for the vacancy is received, an election will be held on August 26th for the Wards involved.

Should an election be required, advertisements will be placed in the local newspapers stating the names of candidates, the Wards in which they are standing for election, and the location of polling booths.

# "NEW SOCIAL DEVELOPMENT MANAGER FOR CAULFIELD"

The City of Caulfield has a new Manager of Social Development.

John Wise was recently appointed to the position after having spent the last three years with the City of Mordialloc as the Head of the Department of Social Development.

He succeeds Don Saltmarsh who has taken up his seat as the Member for Waverley in the Legislative Council.

DEGREE IN SOCIAL WORK

John Wise graduated from the University of Adelaide and the South Australian Institute of Technology in 1972 with a Degree in Social Work.

During his studies in Social Work, John also worked parttime for the Prisoners Aid Association in Adelaide.

After graduation, Mr Wise worked for two years as a full-time worker for the Association.

EX-CLERGYMAN

Although John has spent most of his past in South Australia, he spent five years in Melbourne in the early sixties. "From 1960 to 1965 I studied at the Church of Christ Seminary in Glen Iris. I returned to Adelaide and carried out my duties as a Minister for the following seven years." John said.

"After that, my part-time work with the Prisoners Aid Association convinced me that I should concentrate my efforts in the welfare field."

"Apart from all the management responsibilities that come with this position, I am very interested in encouraging the participation of volunteers in both the planning and delivery of welfare services for the City of Caulfield," John said.

"I see part of my role as working closely with local community groups to improve the general range of services.

"One of the problem areas that interests me personally is the provision of accommodation for low-income families."

John Wise is married with 3 children, and presently lives in Parkdale.

# "MEALS-ON-WHEELS" NEEDS YOUR HELP

Volunteers are urgently needed for Caulfield Council's "Meals-on-Wheels" Service.

This service prepares and delivers over 250 meals a day to residents throughout the City of Caulfield.

Both voluntary drivers and "jockeys" are wanted for approximately an hour-and-a-half each week day (11 a.m. - 12.30 p.m.)

Drivers would be required to use their own cars and deliver meals to homes within a particular area of the City.

"Jockeys" would be required to travel with the drivers and take the meals inside the homes of the residents.

Meals-on-Wheels is a vital service. Most of the residents receiving meals are elderly and are unable to prepare nutritional meals for themselves. For many, this service is their only contact with the outside world.

Hundreds of people rely on "Meals-on-Wheels" for their midday meal, and "Meals-on-Wheels" relies on voluntary staff to keep their important service going.

History of Caulfield



In April, 1882, the Shire Hall Committee in Caulfield was offered two acres of land for £700 on which to build their Shire Hall.

A loan was then raised on seven £100 debentures paying 6% interest and payable on the 1st of March, 1914, to the Union Bank of Australia. The Government granted £2,400 to include Court Rooms and a Post Office.

The foundation stone for the Shire Hall, which occupied the present site of the Town Hall, was laid on the 28th December, 1884.

This is just one example of the interesting material being uncovered by authors Peter Murray and John Wells who have been commissioned by Caulfield Council to compile and publish a History of Caulfield.

The authors have been working for several months on Council minutes, newspaper reports and other records in the first stage of their research.

In the second stage, expected to start in September, they will be concentrating on field work. The authors will be contacting long es-

tablished families and other sources for information and illustrations.

The third stage will involve the completion of the manuscript which is anticipated to be more than 300 pages containing over 90,000 words, and will be heavily illustrated.

The authors aim is to write a history for the Caulfield people.

In the next issue of "Caulfield CONTACT", residents will be advised on how they can contact the authors to contribute historical information, documents, and illustrations.

# IS YOUR DOG REGISTERED?

During the month of May, 37 dogs were impounded by Caulfield Council's Ranger, after they were found roaming the streets.

Council records showed that only 14 of these dogs were registered.



Barry Boyle, the Manager for Inspection Services at Caulfield Council said that stray dogs are a big problem in the municipality.

"The only way we can control this problem is if dog owners co-operate with this Council and make sure their dogs are registered with us by the 10th of April each year," Mr Boyle said.

"It is the responsibility of dog-owners to make sure that their dogs are registered at all times. But that is not where their responsibilities end.

"Dog-owners must ensure that their dogs wear the identification disc issued, and that their dogs are under control at all times when in public areas," Barry added.

"If a dog happens to be injured or lost, the identification disc enables us to contact the owners."

All dogs over the age of six months are required to be registered under the Dog Act.

The registration fee is \$7.00

The registration fee is \$7.00 per annum for an unsterilized female dog, and \$3.00 per annum for all other dogs.

Pensioners are entitled to register one dog for a fee of \$1.00 per annum. This does not apply however to the registration of unsterilized female dogs, where the full fee is charged.

"Unfortunately, it is getting to the stage where we may have to carry out a house-to-house survey to overcome the problem of unregistered dogs," Mr Boyle

"And when you consider that under the Dog Act the maximum penalty provided for owners who fail to register a dog is \$20.00, residents may well realise that it is far cheaper to have their dog registered now," he said.




## THE NEXT STEPS



## THE EARLY DAYS OF HEATHLANDS HOSTEL



In the early days of Caulfield, back in the 1850's and 1860's, the area comprising the City of Caulfield was known as Heathlands.

On May 30th, 1976, Caulfield Council officially opened their second personal care hostel for the aged and named it "Heathlands."

Here we take a look at the early days of HEATHLANDS HOSTEL - a hostel that offers personal care and supervision to forty-four aged residents.

"HEATHLANDS" situated at 15 Hawthorn Road, North Caulfield, provides a social environment for the aged where they canshare companionship and common interests, and yet retain their independence by living in individual accommodation units.

As the average age of residents at the Hostel is 80 years, each person is required to have their own personal doctor who visits them regularly at their own

The hostel has 44 individual units providing residents with their own bed-sitting room, bathroom, 'phone and television. There is a communal diningroom, lounge-room, and laundry. There are two full-time

residential staff at "HEATHLANDS", and three residential part-time staff members.

They are responsible for the provision of meals, giving mecication, and assisting with bathing, laundry, and room cleaning when required.

The total cost for HEATHLANDS HOSTEL was close to \$900,000.

Almost two-thirds of this amount was made up from a Commonwealth Grant under the Aged or Disabled Persons Homes Act.

The remainder of the funds for

the Hostel were raised by donations from various Community Organisations, and donations from the aged residents living in the Hostel.

HEATHLANDS" residents are charged \$30 per week which covers full board, meals, electricity, heating, laundry and nursing care.

The Hostel also receives a Commonwealth Grant of \$15 per week for the care of each resident over the age of 80. "Heathlands" Hostel, like

many other of Caulfield Council's community buildings is selfsupporting and operates at no cost to the ratepayers of this

## Third Aged Hostel planned in Murrumbeena

Lions Clubs to help raise funds

After the successful opening of Caulfield's two personal care Hostels for the Aged -"Camden Court" in 1974, and "Heathlands" in 1976, plans are already underway for a third hostel to be built in Murrumbeena.

Caulfield Council has already bought a property in Ames Avenue, Murrumbeena as a probable site for the Hostel.

Caulfield, Carneige, and Elsternwick Lions Clubs are jointly to be involved in raising funds for the project.

The target that the Lions Clubs have set themselves is \$100,000 towards a total estimated cost for the project of approximately \$850,000.

The Lions Clubs plan to raise the money through their Annual Men's Dinner, and by holding various raffles, art shows, and special events such as a Banquet Auction and a Command Performance Variety Show.

Caulfield City Manager, Mr Wilson said that the Lions Clubs were very enthusiastic about raising funds for the third hostel in Murrumbeena.

"Unfortunately, due to the uncertainty of the amount of government grants that will be available, and the large amount of money that needs to be raised, we don't anticipate being able to start building this hostel for at least five years," Mr Wilson said.

"Although Council bought the Ames Avenue site with a third hostel in mind, this may not be the final choice for the location of the hostel, considering the length of time it may take before building can commence, and the changing circumstances that may occur.

"However, the Lions Clubs asked if they could start their fund-raising efforts for a third aged hostel now, and the Council was delighted to accept the interest and support of these Lions Clubs in raising money for the project," Mr Wilson said.

# RESIDENTIAL PARKING PERMITS

Residential Parking Permits are available for residents who face restricted parking areas outside their own homes, and who have no frontal access for their vehicle.

Residents of flats where there is no provision for off-street parking will also be eligible for the permits.

The Residential Parking Permits will be issued in the form of a car transfer which allows a resident who has a restricted parking zone in his street, to park his car for unlimited periods outside his own home.

Caulfield Mayor, Cr. Sam Taylor, said there had been many requests by Caulfield residents for such permits.

"Restricted parking zones were initially introduced in residential streets to ensure that everyone had a chance to use prime parking spaces."

"Council realised that this also meant that some local residents were at a disadvantage. These permits will now rectify the situation," Cr Taylor said.

There will be an annual permit fee of \$2, renewal in January of each year, and application forms are available from the manager of Inspection Services at Caulfield Town Hall.

Pensioners will be issued the permits free-of-charge.

1. TRUE. The Local Government Act requires that three Councillors represent each ward of a municipality.

Weights and Measures

The City of Caulfield has four wards, which means a total of twelve Councillors. Council has no power itself to vary the number of Councillors representing each of the four wards.

2. FALSE. The Local Government Act requires that Councillors are to be elected for a three year term.

Each year, one Councillor from each of the four wards is due to retire. This system enables a Council to operate as an effective policy-making body, as there are always at least eight experienced Council-

lors working in Council at all times.

 TRUE. Eligible voters have a choice of whether they wish to vote or not.

The adoption of compulsory voting can only be undertaken by a Council following application and approval from the Governor-in-Council.

Discussions are currently taking place at State Government level to change the date of Council elections so that they do not clash with school holiday periods.

It is likely that in 1977, elections will be conducted early in August.

5. TRUE. The Local Government Act allows a property-owner to cast a vote at elections in each of the wards that he or she owns property in.

However, irrespective of the number or properties owned within a single ward by a particular person, only one vote is permitted to the owner for voting purposes in that ward.
