# Historic decision on heritage areas

I len Eira City Council recently made an historic I decision to approve the municipality's first heritage areas. It approved heritage controls on 58 individual properties and eight heritage areas: Beauville Estate, Caulfield North, Crompton Court, Gladstone Parade, Glen Huntly Park Estate, Hillcrest Estate, Park Crescent and South Caulfield.

sites attracted 68 submissions overall- representing about 1.4 per cent of people in the proposed heritage areas.

The most contentious areas are Lempriere Avenue, Vadlure Avenue and Myrtle Street/Bailey Avenue. An amendment proposed at the meeting that residents in these streets be given the option of voluntary heritage

These will now go to the Minister for Planning and Local Government for final approval.

There was volatile debate on the heritage issue at the Council meeting on 26 April, including heated interjections from the large gallery present, particularly on the proposed heritage overlay for Lempriere Avenue.

Council decided to split the heritage Amendment L33, and approve the areas which did not attract submissions- about half of the amendment.

It will refer the remaining sites (12 individual properties and nine heritage areas) to an independent panel, which will be appointed by the Minister. These controls was defeated.

The independent panel will provide a further opportunity for people who made submissions on the heritage amendment to be heard. The panel's report is likely to come back to Council in late 1999 for final consideration.

The approved section of Amendment L33 represents Glen Eira's first public process heritage areas. Heritage protection has been a topical issue since the early 1990s, and early research on heritage and historic character of our buildings led to the Heritage Management Plan being initiated in 1996, and a lengthy community consultation process to introduce heritage controls. continued page 3

### **Apartment complex in Centre Road** approved

A proposed three storey apartment building comprising twelve units and a mix of residential and commercial car parking in Centre Road, Bentleigh, has been given planning approval. The site is between Wheatley Road and Rose Street and is currently used as a car park.

Three objections and a petition against the proposal were received, however Council decided that a permit should be issued as it felt that the development was consistent with the objectives of the Good Design Guide and Council's Municipal Strategic Statement.

#### Master plans for three parks

Council adopted master plans, which set out designs for various improvements to each park, for three

major parks- Allnutt Park, Harleston Park and Hopetoun Gardens- following consultation with affected residents. Development works from the master plans will take place over the next two years.


### Excellent response to wards and Councillor questionnaire

Heritage as an issue polarises resident opinion. While there has been a vocal minority in opposition, it is equally clear there is considerable general support for heritage management. Council has emphasised that heritage management does not mean "freezing" existing building forms. Responsible management does mean that the best examples of past buildings can be considered when assessing new development proposals. In this way, heritage management can see the continued enhancement of a heritage area.

### **Ocean St approval**

A compromise solution has been reached on an extension to a house in a proposed heritage area in Ormond.

Glen Eira City Council and Ocean Street property owner Gordon Arthur have agreed on some design changes as part of his plans to build a second storey, which will see the retention of heritage features at the front of the Californian bungalow-style house.

Council had originally refused a permit to demolish the whole of the main front gable and verandah roof, because it would compromise the heritage value of the building.

Council has now approved all 31 applications for demolitions or part-demolitions of properties in proposed heritage areas, since the Minister for Planning and Local Government approved interim demolition controls.

City Development director Jeff Akehurst said: "This shows the flexibility of controls on heritage areas. Heritage issues must be considered in looking at planning permit applications, but it does not necessarily prohibit demolitions or other alterations or extensions.

"Heritage controls provide a way for Council and the community to negotiate, and work together to protect Glen Eira's heritage for the future."

### What if your property is now in a heritage area?

ritage overlay controls were approved by Council on a number of individual properties, and for the following areas: Beauville Estate, Murrumbeena; Caulfield North area, Caulfield North; Crompton Court, Caulfield South; Gladstone Parade, Elsternwick; Glen Huntly Park Estate; Hillcrest Estate, Caulfield South; Park Crescent, Caulfield North; and South Caulfield Shopping Centre, Caulfield South.

new drop-in centre for parents of infants A and pre-schoolers was opened recently at Carnegie Maternal and Child Health Centre. Cr Veronika Martens launched the program by releasing a colourful bunch of balloons with parents and children (pictured).

Cr Martens welcomed parents and said the service was developed in response to a need which had been identified by the regular attendance at the centre and was a clear example of Council listening and responding to the needs of people in Glen Eira.

"The drop-in centre is being trialed for six months and I sincerely hope it will become a permanent service. We had an encouraging turn out at the launch, and this included fathers which was great to see," she said.

The drop-in will operate at the centre at 9 Jersey Parade, Carnegie on Tuesdays from 1pm to 3pm, and aims to fill the gap for parents who need occasional support and company, but not on a regular or organised basis.

The service provides a means for parents who might be isolated to meet other parents, as well as an opportunity to find out about other community activities and parenting information. Parents can come along and enjoy a cuppa and conversation with other parents.

"Council has been responsible in taking action to develop heritage controls, that will see the best examples of this city's built heritage recognised, protected and with opportunities for enhancement," he said.

# Your street, your sayor is it?

# Medium density housing— who really is shaping Victoria's suburbs?

The building boom of recent years which particularly includes medium density housing has resulted in tensions within the Glen Eira community, as residents witness changes to the urban character of their streets first hand.

But who actually makes the decision to accept or reject development in our city? The residents? The developers? Council's planning officers? Council's Development Approvals Co-ordinating Committee (DACC)? The State Government? Or the Victorian Civil and Administrative Tribunal (VCAT)?

The State Government has been keen to distance itself from this responsibility and State Minister for Planning Rob Maclellan is eager in his response that it is Local Government which has town planning permit control. But the reality is that Local Councils must make decisions about medium density housing based on a pro-medium density housing base.

City Services Director Jeff Akehurst said three levels of constraint operate: Glen Eira Planning Scheme, State Planning and Environment Act, the and the Good Design Guide. He said all Council planning decisions must be filtered through these policies.

Mr Akehurst said Council was obliged to operate under a State Government law which required it to "...facilitate appropriate development" and to "...balance the present and future interest of all Victorians".

"Even the 'Glen Eira Planning Scheme', which by its name would appear to be operating at a local level, is in fact a 'State Planning Policy Framework'. This is a State Government imposed policy, by which we are required to abide," he said.

This framework's objectives are "to encourage residential development that is cost effective in infrastructure provision" (ie put housing closer together) and "to encourage opportunities for increased residential densities to consolidate urban areas."

# "Let's Join In"

An inclusive program for all children

Let's Join In is a Commonwealth Government and Glen Eira City Council sponsored program, staffed by Children's Services Resource and Development Officers (CSRDOs), who are commited to ensuring all children can access appropriate Commonwealth funded children's services. Mr Akehurst said Council was also operating within the guidelines of the *Good Design Guide*, which was previously called 'Vic Code' and is a State Government guideline. Its objectives are clear: "promote well designed medium density developments", "encourage a variety of dwelling types" and "encourage innovative contemporary design".

"In other words, don't mimic the existing character of the suburb, but actively develop different design elements," Mr Akehurst said. This equates to State Government Policy driven change.

Council has developed "Local Variations (to the Good Design Guide)", a process all councils are encouraged to undertake. This is a set of guidelines which operate in addition to the Guide, but are specific to a local area, and must be approved by the State Minister. Developers are required to comply with these local variations when applying for permits.

But in Glen Eira's case these local variations have not yet been put to the minister for approval. Mr Akehurst said the minister's requirements were unrealistic in terms of giving local variations any statutory power.

"Furthermore, Council can reject an application based on failure to comply with local variations, but if the developer then appeals and takes the application to VCAT, VCAT can decide to overlook those variations and grant the permit. Yet another example of the matter being taken out of local hands," he said.

Since the beginning of August 1998, the majority of appeals against Council have been lodged by applicants appealing Council's decision to refuse their application for medium density housing. However, it is perhaps significant that residents are not taking Council's decisions to appeal, possibly indicating a degree of satisfaction with Council's decision making.

One of the greatest claims of residents' groups opposing medium density housing is that they oppose



"inappropriate" development. But Mr Akehurst said Glen Eira City Council also "opposed inappropriate development".

"What it comes down to is your definition of 'inappropriate', and whether you believe planning decisions are made with only the existing residents in mind. As a Council, we are planning for today and the future, that is, every day after tomorrow," he said.

"The DACC sees planning being about our ability to wisely create the world in which existing residents' children and grandchildren will also live."

He said a number of changing dynamics in family structure and lifestyle has led to the changes in housing characteristics. The "nuclear" family is no longer the majority of household formations, and in the last decade, a shift has occurred towards smaller dwellings with less open space. People are living longer and working less hours, they are having less children and often both parents are working. More people are also seeking proximity to urban facilities.

Mr Akehurst said these issues were significant and needed to be put into the picture to balance the opposing view of "maintaining neighbourhood amenity and character"— this balance is what makes planning decisions difficult, he said.

"There's no doubt about it, medium density housing is an emotional issue. But we'd like to think people are aware of the bigger picture and the constraints under which Council is operating. Also, it's important to note that many of the applicants are falling into line with Glen Eira's local variations. Council planning officers are conducting post-occupancy interviews and getting positive feedback from the owner/occupiers, architects and neighbours about many of the developments that go ahead," he said.

# Keep "Lassi leashed!

O wning a pet can be a rewarding and pleasurable experience for people of all ages. Pets provide love and companionship and add enjoyment to life for many people. A big part of being a responsible pet owner is knowing what your pet actually needs and knowing what is expected of you— one aspect of this is keeping your dog under control.


Dogs wandering at large are a regular occurrence in the City and one that Council is aiming to reduce. Apart from the nuisance that your pet may cause to others by wandering into other peoples' property and leaving its doggy-do on front lawns and nature strips, it is also at risk of causing harm to others if left uncontrolled and may even injure or kill itself by running onto roads. Furthermore, owners may be liable if their dog attacks a person or another animal, damages property or causes a traffic accident.

Council is intending to become stricter on those pet owners who carelessly allow their pets to wander without supervision. Pet owners may be issued with on the spot fines of \$50 if their pets are found to be not suitably confined to the property boundaries. Council Animal Control Officers may also impound a pet if it is found to be wandering unattended. Release fees of \$50 apply in order to retrieve a pet and in some cases, fines will also be issued for the dog wandering at large, also \$50.

Areas within many of Glen Eira's parks are now sign posted as "leash free" areas. In such areas, dogs may be allowed off the leash, but must still be under supervision and be able to be controlled by voice command.

Currently, more than 9000 dogs and 7000 cats are registered within the City. Council hopes to increase this number by at least 10 per cent in the coming year, through increased education of residents, random checks within parks and door-knocking residents.

Registration fees go towards educating the public on responsible pet ownership. The fee also contributes to the employment of two Animal Control Officers,

whose role includes patrolling the City's parks, dealing with all animal-related complaints, collection and caring for lost pets and finding their rightful owners.

About 30 per cent of pet registrations are made by pensioners. Most people have desexed animals, with only about 800 people paying the maximum fees for non-desexed animals. These fees are \$81 for dogs (up \$3) and \$53 for cats (no change).

Quite a number of fines were issued last year by the Local Law department and some residents were prosecuted in the Prahran and Melbourne Magistrates' Courts for failure to register their pets.

### **Responsible pet ownership**

Being a responsible pet owner means registering your pet with the local Council. There are many benefits of this including providing an excellent form of identification should your pet become lost.

In many ways, common sense prevails. Provide adequate food, water and shelter for your pet, ensure your pet is healthy by vaccinating, worming and controlling fleas, and provide enough exercise and socialisation with other pets in the community.

De-sexing also needs to be considered. This helps reduce the number of unwanted puppies and kittens in the neighbourhood. De-sexing can also minimise the development of aggressive tendencies in dogs, and in cats can reduce the tendency to spray and mark their territory. De-sexed pets are also less prone to wander.

Owners are encouraged to confine their pet to their own property by ensuring dogs are housed behind a gate or fence and ensuring cats are kept inside at night. Also, it is important to find suitable boarding accommodation for pets when the owner goes away on holidays.

Responsible pet owners always clean up after their dogs. Faeces left in public open spaces is offensive to others and is also a huge health risk to both other pets and humans alike.

Council's Animal Control Officers are happy to provide further information about responsible pet ownership issues and can be contacted through the Council offices. Written literature is available upon request.

# Arthur Boydmemories of a Murrumbeena childhood

Glen Eira City Council pays tribute to internationally acclaimed artist Arthur Boyd with a display of his and his family's works at the Town Hall— including the painting *Murrumbeena Farm*, works by several members of the family, news cuttings, and pottery.

Arthur Boyd, who died in Melbourne on 24 April, aged 78, was a member of the famous Boyd family of artists, who lived in Murrumbeena.

The family has produced many artists, sculptors, writers and architects of note through several generations— a tradition which continues today. Arthur Boyd's father Merric was a potter, his mother Doris, a painter. His paternal grandparents, Arthur Snr and Minnie Boyd, were also artists, and uncle Martin Boyd was a writer.

Merric and Doris Boyd set up their home and pottery called *Open Country* at 8 Wahroonga Crescent, Murrumbeena and raised five remarkably talented children— Lucy, Arthur, Guy, David and Mary who have all made a significant contribution to the arts in Australia and overseas.

Arthur Merric Bloomfield Boyd was born in 1920. He went to Murrumbeena Primary School and began painting at 14 years of age when he attended night classes at the National Gallery of Victoria. At different stages during this period, he worked in a paint factory, lived with his grandfather in Rosebud, and worked as an assistant to builders and carpenters.

In 1943, after serving in the Army, he worked with John Perceval and Peter Herbst at a pottery at 500 Neerim Road, about a kilometre from *Open Country.* (It had been the pottery of older sister Lucy and her husband Hatton Beck, who established the site in 1935. Brother Guy Boyd, a potter and sculptor, later set up another pottery in Murrumbeena Road, near North Road, with his wife Phyllis.)

The reputation of Arthur Boyd, potter, sculptor and painter, grew and he was commissioned to make a 30-foot sculpture for the Olympic pool for the Olympic Games in Melbourne. He moved to England in the late 50s, then returned to Australia in the 1980s to establish Bundanon, a property on the Shoalhaven River in NSW.

A neighbour, Sandra McGrath, said: "He wants to turn Bundanon into a sort of artists' centre, like Murrumbeena, the house where he was born in Melbourne— a place for painters to paint, writers to write... I think Bundanon is the extended Murrumbeena." (*The Australian, November 20 1982*)

In 1993, Arthur Boyd gave his property, near Nowra, to the nation to be a working centre for the arts and a place for families to enjoy. He was made Australian of the Year in 1995, and was awarded an MBE for service to the arts.

Merric and Doris Boyd lived in Murrumbeena until their deaths in 1959 and 1960 respectively. The house was demolished for units in the 1960s.

In 1991, Caulfield Mayor Cr Veronika Martens successfully proposed that the former Outer Circle Railway land in Murrumbeena be named Boyd Park in honour of the Boyd family.

The Boyd family also donated a number of works to Caulfield Council, which are now part of the City of Glen Eira Permanent Art Collection. They include the sculpture *The Swimmer* by Guy Boyd located outside the town hall, pottery by Guy Boyd and Merric Boyd, paintings by Minnie and James Boyd, and Arthur Boyd's *Murrumbeena Farm*, painted in 1936, is on permanent loan to the City.



Popular actor Alan Hopgood appears in this Holocaust-based story playing the





### New Format Glen Eira Planning Scheme adopted

The New Format Glen Eira Planning Scheme has been adopted by Council. The scheme was reviewed by an independent panel and was adopted at the Council meeting on 17 May. The scheme has now been referred to the Minister for Planning and Local Government for approval and could become operational as early as July.

In 1997 as part of the State Government's planning reform process, Council prepared the new format planning scheme which was exhibited later that year.

The scheme contains selected Standard State provisions from the Victoria Planning Provisions, a municipal strategic statement (MSS) state and local planning policy frameworks, standardised zones, overlay controls and maps.

It is important to note that the existing scheme will be revoked as soon as the new scheme comes into operation. This information is being brought to the attention of residents and developers mainly because there may be decisions made in the near future where an application is made under the existing scheme but is then determined under the new scheme.

Some of the following transitional provisions will apply between now and when the new scheme becomes operational:

- The State Planning Policy Framework and the Municipal Strategic Statement must be considered before the decision is made.
- If the application is for a purpose for which a permit may not be granted under the new scheme the application must be refused.
- If the application is for a purpose for which a permit is not required under the new scheme, the application is no longer required (in some cases applications which have been advertised and which may have attracted objections, will no longer require planning permission).

Other provisions have also been made for referral of planning applications, giving notice/advertising, appeals, enforcement and amendments.

A more detailed practice note is available over the counter at Council's Town Planning Department.

# Brighton Cemeteryan interesting place to visit

**B**righton Cemetery, corner of Hawthorn Road and North Road, is a fascinating place to visit. It covers an area of about 12 hectares, the surrounding brick wall is 1.6 kilometres long and the internal roads and paths originally measured 110 kilometres.

The cemetery opened in September 1855 and is now officially closed for burials, although there are still a few plots left. The "Lodge" residence was built in 1892 and has a heritage classification; the office was added in 1928. The non-denominational Lawn Cemetery was established in 1958. Council is considering heritage overlay for the cemetery in its heritage management plan.

The first burial was that of John Alexander, "buried as a poor man" in September 1855. The grave was never marked and the location is not known. The first official burial was a baby, Johanna Manson, aged 10 months, on 14 October 1855.

Since then there have been more than 64,000 burials including such notable people as Adam Lindsay Gordon (Australian writer and poet who shot himself on Brighton Beach in 1870 at the age of 36. His bust was erected in Poets Corner in Westminster Abbey) and Sir John Monash (one of Australia's great citizens who secured a position in history as a World War 1 general). The graves of Frederick McCubbin (one of the famous Heidelberg school of artists) and Guy Boyd (one of Australia's great sculptors) can also be found at Brighton Ceremetery.

The cemetery has its share of dignitaries: Sir Thomas

Bent (Mayor of Brighton, Shire President of Moorabbin, MLA for Brighton and Premier of Victoria) and Mr Justice Higinbotham (Editor of The Argus, MP for Brighton and Chief Justice for Victoria). Other famous people include author of the Australian classic Robbery Under Arms Thomas Alexander Browne (Rolf Boldrewood), and notorious 1920s gangster Joseph Theodore I ("Squizzy") Taylor. Worth a look

If you have an interest in local history, why not obtain a copy of the cemetery guide from the office and spend an hour or two wandering. The office is open 1.30 to 4.30 pm Monday to Friday and the gates are open 8.30 am to 6pm daily.

As part of Council's Disability Action Plan, a profile of the incidence of disability within Glen Eira has now been completed. Council Disability Advisor Sharon Granek summarises that profile.

**C**ouncil's Disability Policy and Action Plan has now been lodged with the Human Rights and Equal Opportunity Commission. Throughout Australia 39 Local Governments have lodged plans seven in Victoria. An identified action in Glen Eira's plan was the need to develop a profile of the incidence of disability in Glen Eira.

#### **Glen Eira profile**

- Glen Eira has a higher proportion of aging population (21.4 per cent of Glen Eira's population is 60 years or over compared to the Victorian total of 15.9 per cent).
- A marginally higher proportion of people have a physical or sensory handicap.
- A higher representation of people have a profound or severe handicap; 4055 people (3.4 per cent) with a profound handicap, compared with the state average of 2.5 per cent and 2371 people (2 per cent) with a severe handicap, compared with the state average of 1.7 per cent.

### Beyond Glen Eira

In the wider community the most prevalent forms of disability are physical and sensory, with physical disability accounting for nearly three quarters of all disability types— 22 per cent of the entire population have a hearing problem and a further 80 per cent of people 45 years or over, have some form of vision impairment. One in five people will experience or have experienced a psychiatric illness (this translates to more than 24,000 Glen Eira residents).

More than 21,000 people, or 18 per cent of Glen Eira's population of 121,460 residents (as at June 1997), experiences some form of disability.

A disability is defined as a loss or reduction of functional ability which results from impairment. A handicap is defined as the disadvantage caused by a disability (ie the social consequences which may result from a disability). Not all forms of disability need result in a handicap.

The table (far right) shows a breakdown of the major disability types and the numbers of people with a handicap within the City of Glen Eira.

Glen Eira has a number of distinguishing characteristics. In comparison to Victoria:

### Age and disability

The prevalence of disability and handicap increases with age, with older people much more likely to experience a handicap as a result of their disability.

Due to the aging of the population in general, it is predicted that the growth in handicaps associated with disability will increase by more than 67 per cent between 1996 and 2011. Profound and severe levels of handicaps will also increase by at least 0.17 per cent per annum.

The Australian Bureau of Statistics released figures at the end of April indicating there are now 3.6 million Australians with a disability. Since surveys were first conducted the rate has steadily increased from 15 per cent in 1981 to 19 per cent in 1998.







# Linking communities to protect youth at risk

The Cities of Glen Eira, Port Phillip and Stonnington recently launched the regional School Focused Youth Service at a breakfast at Albert Park College.

The project, covering the three municipalities, has been established to prevent young people at risk falling through the "gaps" in the system.

The project's theme is "linking communities, building relationships, supporting young people".

It is funded by the Departments of Human Services and Education, as part of the Victorian State Government's Suicide Prevention Strategy, and is a co-ordinated approach to improving access to appropriate and timely support from community services for young people at risk.

The launch, by the Glen Eira, Port Phillip and

community services, who are all working jointly to implement the project.

Co-ordinator of the School Focussed Youth Services Michelle Balthazar said the first phase of the program had received a fantastic response form both schools and community organisations.

"People are really embracing the concept. The first step is to identify the needs of young people via a survey, which we have sent to schools and youth agencies. We will be able to determine the top issues facing kids at risk, and structure support for them accordingly," she said.

Ms Balthazar said the launch had been well attended by about 60 people, who enjoyed a breakfast prepared by the students of Albert Park College. Guest speaker Associate Professor from Victoria University Maureen Ryan spoke about the need for collaboration between youth support agencies and the importance of learning to work together.



Recent public meetings have been held for Caulfield, Bentleigh and Packer Park. These meetings have been well attended and have been facilitated by the landscape architect and Council officers. At these consultations, residents have been involved in workshops to consider the important aspects of the park including areas that could be improved. The landscape architect will use this information as the basis of a draft plan after consultation with the relevant Council departments.

Residents will be notified in the local press when the draft plans will be on display so that final comments can be received. The draft plans will then be presented to Council for adoption.
