1. Discuss the pre- and post-operative care of a patient undergoing radical mastectomy for carcinoma of the breast. —[30 marks]
2. (a) (i) State what substance is used in mass immunization (e.g., the Army) as prophylaxis against tetanus. —[1 mark]
(ii) How many injections are required and at what intervals? —[2 marks]
(iii) What type of immunity is produced? —[1 mark]
(iv) Is any danger associated with the use of this substance? —[1 mark]
(b) (i) What types of wounds are likely to be infected by the *Clostridium tetani*? —[2 marks]
(ii) What substance is necessary to give protection to a person not previously immunized? —[1 mark]
(iii) What dangers are associated with these injections? —[2 marks]
(iv) What precautions are taken to minimize such dangers? —[2 marks] —[12 marks]
3. What observations should be made of:—
(a) the water-seal drainage after thoracotomy; —[4 marks]
(b) the extremity of a limb recently encased in plaster? —[4 marks] —[8 marks]
4. (a) Why is there a risk of excessive bleeding in operations for the relief of obstructive jaundice? —[2 marks] —¹/₂
(b) What substance is given to reduce this risk and by what route is it given? —[2 marks]
(c) What are the indications that the common bile duct is patent and that it is safe to remove the T tube after choledochostomy? —[6 marks] —[10 marks]
5. A young patient detained in a Casualty Department is unexpectedly required to have a general anaesthetic. State five (5) questions to be asked of this patient, giving the reason for each. —[10 marks]
6. (a) What are the two main divisions of fractures and why is one much more important than the other? —[2 marks]
(b) Define and give an example of:—
(i) complicated fracture;
(ii) pathological fracture;
(iii) internal fixation of a fracture;
(iv) skeletal traction. —[8 marks] —[10 marks]
7. (a) What is the daily fluid requirement of a patient having an intravenous infusion in the treatment of paralytic ileus? —[2 marks]
(b) How many calories are supplied by 2 litres of 5% dextrose solution? —[2 marks]
(c) What are the signs and symptoms of acute circulatory overloading and what is the immediate treatment? —[6 marks] —[10 marks]
8. What term is used to denote the following:—
(a) localized collection of blood in the tissues;
(b) blood in the peritoneal cavity;
(c) dark stools containing partly digested blood;
(d) bleeding into a joint cavity;
(e) uterine bleeding between menstrual periods? —[10 marks]
