

### LEGACY publishes this Annual Report for three reasons —

- to thank our friends and supporters for the help given during 1979 and to show them that we have a continuing task,
- to extend the knowledge of Legacy's work in the community so that eligible widows and children may seek help from us,
- to provide background reference information for more than 900 members of Melbourne Legacy.

Economy dictates that we must do these three tasks in one slim volume. We hope that the information we give answers most of the questions you would like to ask.

#### THE SPIRIT OF LEGACY IS SERVICE

Legacy is a voluntary association of returned exservicemen pledged to bring comfort and assistance to widows of ex-servicemen and their dependent children throughout Australia.

Legacy assists not only the dependants of men killed in action, or of those whose deaths are attributable to war injuries, but also those dependants of all men who served in war areas and who have since died from any cause whatsoever.

#### THE CHARTER

"The care of dependants of comrades who served their country in war and who died on service or subsequently, affords a field for Service. Safeguarding the interests of children is a service worth rendering, and their interests include their mental, moral, vocational and physical welfare.

"Personal effort is the main essential. Inasmuch as these are the activities of Legacy it is your privilege to accept the Legacy of fallen comrades."

# The President of Melbourne Legacy Reports — 1979

From the early years of Legacy's long life, the main thrust of our members' compassionate interest and activities was aimed at safeguarding the interests of the children of our departed comrades who served their country in war.

With the progressive decrease in the number of dependent children in recent years, we have witnessed a transition in both our family contact role and in our various Junior Legatee committee activities. This, of course, has directed far greater emphasis by Legatees towards the support and assistance of widows living alone or in institutions, without adequate family support.

The number of widows enrolled with Melbourne Legacy increased from 16,717 in 1976 to 18,498 in 1979 and it is anticipated that this number will increase in the years ahead which indicates a significant area of need, likely to extend into the 21st century.

Bearing in mind the provisions of our Charter, a special study into our present and future commitments was undertaken during the year with the objective of establishing and defining the extent, nature and direction of our work, and the manner in which the task is to be tackled.

This report will make brief reference to certain aspects of this study, which summarised its conclusions with the following words:

"The way ahead for Melbourne Legacy is to continue in accordance with The Charter to provide eligible widows and children with such additional support, beyond the support available to the general population, as is necessary to provide reasonable comfort, security and advice for the widows and sound education and guidance for their children. There must continue to be a Legacy commitment, and organisation to support it, tailored to fit the need, as long as the need exists."

#### **Our Patrons**

Melbourne Legacy has continued to receive strong support, and keen personal interest, from our distinguished Patrons.

His Excellency the Governor of Victoria, The Honourable Sir Henry Winneke, honoured our Club with his presence on several occasions during the year and we were particularly grateful for his inspiring address at the school children's annual ANZAC Commemoration Ceremony at the Shrine of Remembrance and for his opening of the Legacy-in-Victoria Conference in June.

We are also extremely grateful for the continued support and keen interest of our other Patron, Lieutenant-General, The Honourable Sir Edmund Herring, whose presence at various functions and tremendous encouragement has been an inspiration to all members of the Club.

#### **Legacy Friends and Supporters**

The magnificent assistance and support of so many long-standing friends and supporters was again well in evidence throughout the year and the continued generosity of our many friends and supporting organisations is gratefully acknowledged.

The work of Legacy, which includes in many cases, the provision of financial assistance and support of Legacy Widows and Junior Legatees would certainly be less effective without the generosity and encouragement of so many thoughtful people in our community.

We are also conscious of the practical support and understanding of many kindred organisations including the Returned Services League, Carry On, Red Cross and the Victorian Association of Jewish Ex-Servicemen and Women, while the three Armed Services continued their keen interest and support of our activities during the year.

We also received strong support from other community service organisations including Apex, Lions, Rotary and Boy Scouts; and several sporting bodies, especially Huntingdale Golf Club, Melbourne Greyhound Racing Association and the Royal Victorian Bowling Association maintained their support for which we are extremely grateful.

#### Membership

The vitally important aspect of Legatee manpower has been carefully examined again this year.

Currently, the average age of Melbourne Legatees is 61 years, so it is unlikely that the effectiveness of a majority of our members will diminish during the next five years. Authorities point out that the first phase of old age is not reached until one is over 70 years of age. Within Melbourne Legacy we have (and have had) some wonderful examples of what can be done by our older Legatees, so in view of these factors it is considered that our current manpower will be able to render effective service to widows and Junior Legatees until at least 1985.

Nevertheless, it is realised that plans must be laid immediately to provide for an experienced workforce, capable of coping effectively with Legacy's commitments beyond 1985, and this will involve the recruitment of an auxiliary workforce. A special group of Legatees has been given the task of formulating this plan.

Presentations of Fifty Year Service Certificates were made to a further four World War I Legatees during the year. Eighteen Melbourne Legatees have now qualified for this rare distinction.

It is with sadness and deep regret that Melbourne Legacy reports the death of 30 Legatees this year.

Our Club was strengthened by the induction of 50 new members and at 31st December, 1979 our membership stood at 937 Legatees, a decrease of 21 from the previous year.

#### **Legacy Clubs and Groups**

Many honours and privileges are bestowed upon a President of Melbourne Legacy, and amongst these is the pleasant responsibility of representing the Club at the Annual Meetings of other Legacy Clubs and our Groups.

This year I have had the pleasure of visiting Sydney Legacy — with the strong support of ten other members of Melbourne Legacy — while other interstate journeys included visits to the Annual Dinner Meetings of Adelaide and Albury Clubs and to Bundaberg as a delegate at the 51st Conference of Australian Legacy Clubs. The twenty eight members of Melbourne Legacy in attendance provided the largest Club representation at this successful Conference.

It has also been a great pleasure to visit most of the Country Clubs in Victoria as well as our Country Groups and to observe, first hand, that the work of Legacy continues to thrive throughout the State.

#### Ivan E. Layton, M.B.E.

Members of Legacy Clubs throughout Australia, and in particular the members and staff of the Legacy Club of

Melbourne, were deeply saddened by the death, on 15th September, 1979, of our Executive Officer, Ivan E. Layton, M.B.E. Shortly before he proceeded on sick leave in May and, to the delight of all members of Melbourne Legacy, Ivan was inducted into membership of the Club.

Ivan Layton's outstanding service to Legacy spanned nearly thirty years and his magnificent contribution to the work of Legacy will remain as a lasting memorial to this remarkable man.

#### Administration

I wish to acknowledge the co-operation and strong support of our new Executive Officer, Mr. Frank Densten, and to express my sincere appreciation of the loyal and conscientious efforts of all members of Legacy House staff; especially for their ready acceptance of changes in the organisational structure and office equipment.

#### Conclusion

On the occasion of my installation as President of the Club on 10th March, 1979, I stated that a year of office as President of Melbourne Legacy was one of the greatest honours that could be bestowed upon an exserviceman.

All that transpired during the ensuing year totally vindicated this statement.

In addition to the many honours and privileges received, it has been a most rewarding and unforgettable experience to serve the Club in this responsible posting.

I express my sincere appreciation of the support, loyalty and encouragement of my wife and family, the members of the Legacy Wives' Association and each of my fellow Legatees.

# Highlights of our 1979 Year

#### March 1979

- Legatee Bill Mehan was installed as President of Melbourne Legacy at the Annual Changeover Dinner which was attended by many Melbourne Legatees, visiting Legatees and Official Guests representing the Victorian Government, the Armed Services and kindred organizations. On the next day, at a Comradeship Barbecue visiting Legatees were the Guests of Melbourne and its Groups.
- The Annual Legacy, Carry On, Rosanna Golf Club Charity Day was held. The A.I.F. Cup was the feature event and \$1,264 was raised for our Junior Legacy funds.
- The first of six Charity Greyhound Racing Meetings arranged by the Melbourne Greyhound Racing Association during the year was held at Olympic Park. Legacy shares the net proceeds with Yooralla and St. Vincent's Hospital. Since 1964 a total of \$85,739 has been received from this source.
- The annual "Operation Firewood" was again most successful. A total of eighteen trucks comprising fourteen semi-trailers and four tray bodies travelled to Mulwala where, with the aid of front-end loaders, Group Legatees and a grand band of helpers, 350 tonnes of firewood was loaded for distribution in the Melbourne Metropolitan area. Those Legacy widows who still use firewood did not go cold during the winter.

#### **April 1979**

- Legacy's Annual Pilgrimage to the Shrine of Remembrance was led by President, Legatee Bill Mehan.
   The Pilgrimage, of approximately eighty, comprised Legacy widows, members of Intermediate Legacy Ladies' Club, Junior Legatees from "Stanhope" and "Blamey House" and Legatees and their wives.
- Wreaths were laid at the Stone of Remembrance, the President conducted the Ceremony of Remembrance and Legatee Kemsley spoke briefly about the important role Legacy played in influencing the decision to build the Shrine of Remembrance.
- The 48th Annual ANZAC Commemoration for Schools was conducted. 86 teachers and 1094 students representing 61 schools including the band and guard from Melbourne High School and a combined choir from Melbourne High and MacRobertson Girls' High Schools, attended. Seven Turkish children were included in the representation from one Western Suburbs School. The Ceremony was televised.

#### June 1979

- The 29th Legacy Wives' Association Market Fair was held at the Malvern Town Hall. An amount in excess of \$4,600 was raised to assist Legacy in its work.
- Legatee Wal Stephen, Chairman, Club & Group Liaison, hosted the Melbourne Legacy Groups Conference which was attended by delegates from 13 Groups together with the Liaison Officers and several observers. The conference was most fruitful.
- The Legacy-in-Victoria Conference with the theme "Legacy at Work" was opened by our Patron, His Excellency The Governor of Victoria, Sir Henry Winneke. The 141 Legatees present included Presidents of all Victorian Country Clubs or their representatives, delegates and observers. Legatee Frank Nolan, President of Sydney Legacy, also attended. A most successful innovation was the short address given by two Legacy

widows, Mrs. Joan Oakley of Melbourne and Mrs. Betty Baldwin of Bendigo. These widows brought personal knowledge of the problems our Legacy widows face which was of great interest and assistance.

#### September 1979

• Thanks are extended to our many friends — the generous public, members of the press, TV and Radio for their great assistance during Legacy week, our major annual fund raising occasion. A record income of \$125,884 net was received.

#### October 1979

• 51st Annual Conference of Legacy Clubs of Australia was held at Bundaberg, Queensland.

Each of the 47 Australian Clubs was represented and London Legacy submitted an apology.

The Mayor of Bundaberg, Alderman C.J. Nielson, C.B.E., extended a hearty welcome to all delegates, observers and wives before the traditional resolution of loyalty to the Crown was endorsed with acclamation. The Conference was officially opened by the Honourable Joh Bjelke-Peterson, M.L.A., Premier of Queensland, who expressed delight at the very large number in attendance and was most generous in his praise of the people involved in Legacy activities. The theme of the Conference was "Torchlight on Teenagers" and an outstanding address entitled "Dare to Discipline" was delivered by Rev. Allan C. Male.

The programme of Agenda items was very heavy and papers were presented by various Legacy Clubs.

#### November 1979

• The 17th Melbourne Legacy Widows' Club Fete was held at "Legacy House". It was again most successful.

Since 1957 a total of \$63,686 has been raised by our hard working, enthusiastic widows to assist the work of Legacy.

#### December 1979

• The Huntingdale Golf Gymkhana commenced at the Eastern Golf Club in 1933 and has since continued as an annual event.

During the year under review Legacy received \$11,472 and figures since 1952 show a total of \$128,928.

Legacy is most fortunate to have such wonderful support from the Members and Associates of Huntingdale Golf Club.

1380 widows attended the 17th Legacy Widows' Club Christmas Concert — held at the Melbourne Town Hall — to witness a first class performance by the R.A.A.F. Band conducted by W.O.I. James Stryker, supported by the Werribee Choral Society.

During the evening the President of the Melbourne Legacy Widows' Club presented Legatee Mehan with a cheque for \$7,100 being proceeds from the fete and other functions held during the year.

#### February 1980

 The Annual Legacy Pairs Bowls Tournament was held. 152 entries were received and the standard of play was very high. The Sir Dallas Brooks Trophy was won by Blackburn who defeated Faircote in the final.

### Notable Family Welfare and Children's Activities of the 1979 Year

During the year the Retarded Dependants Contact Committee has organised functions at regular intervals which included taking the retarded dependants shopping, to lunches at restaurants and dances at "Legacy House"—all under professional supervision. A two week holiday at "Blamey House" was arranged for about 20 of them in January of this year. Ages range from 16 to 38 years.

The second floor of "Legacy House" has been completely renovated at the cost of \$73,000 to provide a spacious Club-room for our widows, in which they will be able to play cards or bowls, or rest after shopping excursions. Kitchen facilities are provided for preparing snacks or hot meals. A Legatee will be on duty to help solve any problems a widow may have.

In addition to normal contacting we continued, during the year, to keep in touch with all our widows through the 'Newsletter'. 15,000 copies were sent out every two months with information about the many and varied activities of the Widows' Club.

Many functions were held for widows during the past year. These include fetes, card and theatre parties, carpet bowls and concerts at the Town Hall. Country and interstate excursions were greatly enjoyed by those who took part.

Special attention has recently been focussed on the provision of hostel and nursing home accommodation for widows who are no longer able to stay in their own homes. We have acquired a number of units as well as beds in nursing homes, which provide quiet, comfortable and worry free accommodation without fear of loneliness or insecurity. As the number of applicants for such accommodation is growing, more funds may in the future, have to be channelled into this project.

Approval has been received from Patriotic Funds Council of Victoria for the transfer of \$150,000 of Junior Legacy funds to the Church of England Trust Corporation towards the capital cost of erecting and equipping a hostel and nursing home at Glenroy to be named "Colton".

Agreement has been reached with the Trust Corporation for a number of beds to be available in perpetuity for Legacy Widows in this hostel.

During 1979 we organised and conducted camps and holidays, physical fitness classes for boys, gym classes and ballet training for girls, 'adventure camp', 'Adventure cruise' and Outward Bound excursions. This year it is proposed to add a Schools Exploring Society expedition and Youth Leadership Training Classes.

During the past Christmas/New Year season about 60 children, under the supervision of experienced Legatees, went from the metropolitan area to country homes for a two week holiday in the country.

In the reverse direction about 70 children from country areas in Victoria were brought to Melbourne and accommodated at the Victorian Education Department Camp at Somers. They enjoyed many sight-seeing trips and excursions organised by Legacy.


High unemployment amongst young people has been a national problem during the last few years. We have therefore made a special effort to find jobs and arrange apprenticeships for our Junior Legatees. We are happy to say that we have been successful in 85 cases. Our efforts will be intensified this year.

The number of children requiring accommodation in our Residences has fallen off rapidly in the past few years. A decision was taken last year that we will, in future, retain only one residence, namely ''Stanhope'', on a co-educational basis. We are greatly indebted to the Red Cross Society, who own the building, for their approval to the project.

Legatee E.K. (Karl) Robertson is to be installed as the 58th President of Melbourne Legacy on Saturday 15th March, 1980 for the ensuing twelve months.

Karl served in the A.I.F. from June, 1940 to February, 1946. His original unit was 2/1 Survey Regt. R.A.A. with which he served in the Middle East and he later served with 2/1 Flash Spotting Battery R.A.A. and 3 P.W. & I. Unit — with the latter in Borneo.

He was inducted into Melbourne Legacy in 1954, his proposer being former Melbourne President Legatee Ron Foskett (now Sydney Legacy). Because of other commitments, he resigned in 1967, but was re-inducted in 1972.

Karl has served on "Stanhope" and Residences Committees, was Honorary Secretary 1973/76 and Senior Vice-President in 1977. In the last two years he has been a member of Planning and Review Committee and active on a number of Sub-committees.

In civil life our President Elect was an officer of The English Scottish and Australian Bank Limited (now ANZ Banking Group Limited) and occupied senior posts in the finance subsidiary Esanda Limited.

He recently joined the Committee of Management of Mayfield Centre and although retired still retains some business interests. He is an Associate of the Australian Society of Accountants and in 1977 was awarded a Queen's Jubilee Medal.








### Comprising 16 Branches in the Metropolitan Area and 13 Groups
