

TO WHOM PRESENTS SHALL COME

JOHN HARLEY LINACRE & JUNE PAMELA

ACRE (hereinafter called the "Donors") SEND GREETINGS

W H E R E A S The Donors being desirous of perpetrating the memory of their son Andrew John LinaCre through the sport he loved Yacht Racing donate a trophy now in the possession of the Royal Brighton Yacht Club (hereinafter called the "Donee" which expression shall include other Clubs appointed by the Royal Brighton Yacht Club to act in its stead either for the time being or permanently) to be sailed for annually in friendly competition AND WHEREAS the Donors are desirous of declaring the conditions on which such Trophy shall hereafter be held NOW THESE PRESENTS WITNESS that the Donors do hereby grant and assign the said Trophy unto the Trustees hereinafter nominated to be held on the following conditions:-

1. The Trophy to be called "THE ANDREW LINACRE MEMORIAL TROPHY"
2. It shall be preserved as a perpetual Trophy for annual competition between 12 foot Cadet Dinghies that are eligible to compete in the Invitation Race prior to the conducting of the Lord Stonehaven Cup or for whatever class of Race the Trustees of the Donee may from time to time decide.
3. The Trustees of the Trophy shall be the Flag Officers for the time being of the Donee and the property of the Trophy shall be vested in such Trustees but the possession of the Trophy shall from time to time be held by the Club of the Cadet Dinghy winning the Trophy in the annual competition last held until it shall be won by another Dinghy and shall be held subject to such conditions for its safe custody as may from time to time be deemed proper by the Flag Officers for the time being of the Donee.
4. The trophy will be sailed annually under conditions laid down by the Donee or their appointees.
5. All or any of the conditions of this Deed may from time to time be altered and further conditions may be added hereto provided that so long as the Donors are resident in the Commonwealth of Australia no such alterations or additions shall be made without their sanction. Any alterations or additions shall be recorded by endorsement or annexure to this Deed signed by the Flag Officers for the time being of the Donee.
6. The Trophy is to be supported by a Presentation Medallion one to be given to each crew member of the winning Dinghy. An account for

7. The Donors give 50 Medallions to the Donee they to be
used each year for the Winning Dinghy and one to be retained by
the Winning Club.
