# SO NOW WE ARE PART OF THE NEW CITY OF MANNINGHAM!

As you are now aware Wonga Park was removed from the rest of the Shire of Lillydale when it merged with the Shires of Healesville, Upper Yarra and Sherbrooke and was annexed by the new City of Manningham (previously the City of Doncaster and Templestowe). In fact the addition of Wonga Park was the only significant change to the City of Doncaster and Templestowe. Also some of the residents of the previous city of Doncaster/Templestowe would like to change the name from Manningham to Doncaster. The Commissioners of the City of Manningham are reviewing these situations currently.

## **RESIDENT ACTION IS REQUIRED NOW**

On Monday 23 January the new Commissioners from the City of Manningham called a public meeting to "Meet the Residents". Just prior to this meeting one local resident, Bib Stillwell, wrote to most residents stating his view and requesting support by returning a form. He received over 200 supporting replies within two days, and has since received over a hundred more.

After the Chief Executive Officer, Rodney Roscholler, introduced the Chairman of Commissioners, Adam Kempson, who in turn introduced commissioners Hector Davis and Danny Kong, Bib Stillwell was invited to address the gathering. He expressed his view that Wonga Park would probably be better served by remaining part of the Shire of Yarra Ranges. From the rather enthusiastic comments that followed it was obvious to the commissioners that a large majority of those present felt the same way.

### **RESIDENTS ACTION GROUP FORMED**

It was decided that interested residents who felt strongly about this issue form a committee to investigate what could be done to reverse the Minister's decision. This meeting will be held in conjunction with our Association's meeting next Friday, February 10 at the Community Cottage on Old Yarra Road opposite the Tennis Club's club rooms. So we suggest anyone who wants to be involved come along and have your say.

# HOW WILL THE PREDOMINANTLY URBAN CITY OF MANNINGHAM TREAT WONGA PARK?

Issues raised by residents at public meetings include:

- 1. What happens to planning controls, especially the Regional Strategy Plan?
- 2. Loss of the use of a tip.
- 3. Mobile Library.
- 4. Who controls the hall and other community and sporting facilities.
- 5. Pre-school enrolment procedures.
- 6. Recycling collection.
- 7. Burning off is not permitted.
- 8. Tree preservation
- 9. Future subdivision (Doncaster has already been contacted by residents wishing to subdivide).
- 10. Rates change from NAV to Site Value will penalise large land holdings but reduce most residential rates.
