Fraser bust in the future. Would you be able to send them down to us as soon as convenient? We would then deliver each to the new firm - Peter Morley, Meridian Founding, for casting, as we are able to commission him. I spoke to him on the phone today and he assured me of an excellent job{equal to Lemon's} and thought that you may not need them to be sent back for checking before pacing in the gardens. Do you think this would be satisfactory? I shall leave it to you entirely to decide. He was at Lemon's factory today when I phoned and seems to work closely with Mr Lemon. You said you know Mr Morley and were happy with his work. Mr Lemon ceases work when our present job is completed. The Stonemason would be sure to fix them, extra strongly, on the pedestals to prevent further vandalism. The Gardens lighting scheme is nearly complete and will be switched on in a week or so. It will include the Prime Ministers' Avenue and front sections of the Gardens area.

We are unfortunate that one of our staff was recently on holidays in Queensland and would have brought the busts in their cases back, but we missed out on contacting him soon enough. Enid and I will be coming north towards the end of June but will not be returning until the end of July, a bit late I'm afraid. (Enid....friends} Strangely enough, this week, a film company about to make a feature film of Australian History and early Irish rebellion, was here seeking a life or larger life statue of Queen Victoria. They told us that our Sturt St statue was the only one of that size in Victoria!! They want to make a plaster cast of her head using a rubber based mould to do so, and assured us there is no likelihood of statue damage. The idea is that a plaster cast can be pushed over in a scene in the film and the bust smashed. They need that size to get it properly photographed. We are taking all safeguards and getting best advice. Our "Queen" is considered to be outstanding and the best in the land. It certainly is a majestic piece of sculpture.

Please accept again our grateful thanks and we trust that you will be able to send the two casts to us in the near future. Yrs etc. F.J.Rogers

I find some difficulty in composing this letter to you, and it would have much easier, for me, at any rate, if I had been able to have a face-to-face discussion with you. Let me assure that what I am about to convey to you is not in any way meant to be, or allowed to be construed to be, any form of criticism.

Some little time after the bust of Malcolm Fraser was installed in the Prime Minister's avenue, we began to receive the adverse comment about it, and regrettably, this has continued. Most of the comments relate to the fact that it did not appear to be a good likeness, that it was too big, and that it was not sympathetically compatible with the rest of the collection. The Council became concerned about the receipt of such comments, particularly because it felt it was not a good reflection of your late father's established artistic reputation.

There would seem to be validity in some comments, particularly in relation to its size, for the bust is certainly quite large, and larger than each of the others which your father has done over the years.

As to the likeness, this is probably a matter of personal judgement, though I have to confess that as you approach the Fraser pedestal from the north, an appreciation of the likeness is difficult. Indeed one prominent sculptor recently passed the comment to us that the Fraser bust "does no credit to the ability or the memory of Vic Greenhalgh". The matter has now been confounded by the acquisition of the Hawke bust, which is more in keeping with the scale and likeness of the collection, other than Fraser. The Council has now determined that it should commission a new bust of Fraser so that each piece in the collection should be sympathetically compatible and that the artistic reputation of your late Father is able to be maintained at its highest level by reference to earlier busts that he has done.

I recall visiting your Father in mid 1981 at his Studio when he showed me the work he was doing on the Fraser bust, and explained to me the difficulty which he was having in satisfying himself about the work. As I recall he expressed to me how difficult he had found it to produce a good likeness, mainly as he said, because of Fraser's height, and the fact that most times Fraser was not seen in photographic reproductions in newspapers and the like at eye level, but rather was viewed from below.

I am sure that you understand what I have been attempting to say, and that the decision to commission a replacement does not mean any offence to either you or your Mother. Rather it is a genuine attempt I believe on our part to preserve intact the very fine examples of your Father's work. I. C. Smith Town Clerk.
