The Amount of this bequest is invested in the Land mortgage at 4% at call with the exeption of £147.0.0 which is xxxxx invested at fixed deposits in the Royal Bank and £858 which is on the Current account in the xxxxx Commercial Bank. There still remains in the estate a property at Moorabbin, proceeds of which will be divided when sold.

Letter 12/6/20 Lydiard St S, Ballarat To His Worship the Mayor

City of Ballarat G Crocker Esq

Sir, I have the honor by request of the Members of the Municipal Art Advisory Committee to state that they have inspected plans executed by Mr G Clegg for the proposed expenditure of portion of the JY MacDoald Bequest for the beautifying of the Botanical Gardens, and that they meet with their entire approval.

They would like however to suggest, if sufficient funds are available, that the pergola between the Entrance and the Arbor shown in the plan should be repeated on the other side of the Arbor between it and the meeting point of the proposed MacDonald Walk and the Chestnut Avenue, thereby completing the decorative avenue.

The Committee is pleased to note that the plan is in accord with the recommendations made by them to the Council last year, and feel sure that if carried into effect it will not only meet with the approval of the ratepayers, but will also be a permanent attraction in the Gardens and a beautiful and fitting memorial to the late Mr JY MacDonald.
