The Chairman welcomed the members and Mr. Hickford replied congratulating the Chairman on his election.

I have the honor to report that there are six (6) cars in use on the line, sixteen employees (3 stablemen, 1 car cleaner, 11 drivers, 1 driver and repairer).

The stablemen receive 1/- per hour and the head stableman 2/- extra, the car cleaner 1/- per hour, drivers £2:11: 0 for 48 hours, Driver and repairer £2:11: 0 for 60 hrs. (wages sheet attached). There are 38 horses in the stables.

The land the site of the stables is leased as is also a block further North on Sydney Road, the lease has not been renewed since 31st December 1913, consequent on the tramway vesting in the Trust and attention hereto is now necessary, the rental is £36, P.A. payable quarterly.

The Manager Mr. W. F. Skinner is in receipt of a salary (inc. of allowance for rent) of £190 p.a. and his duties are (1) to generally supervise the running of cars.

- (3) purchase fodder,
- (4) overlook repairs to cars, harness etc.
- (5) general supervision of stable work, care of horses, and conduct of men.

RE fares and sections on the Brunswick and Coburg Electric Tramways.

I have gone carefully into this matter and have decided to recommend that the Trust adopt the following sections and through fares.

- 1. Park Street to Albion Street, 1d Section.
- 2. Albion Street to Sydney Road, via Moreland Road, 1d "
- 3. Moreland Road to Bell Street, in Sydney Road, 1d "
- 4. Bell Street to terminus at Baker's Road, 1d "

NICHOLSON STREET BRANCH LINE.

- 5. Corner of Moreland Road and Holmes Road to Bell St. 1d "

Through fares/—

- 1. Park Street to Bell Street, via Moreland Road, 2d "
- 2. Park Street to Bell Street, via Nicholson Street. 2d "
- 3. Park Street to terminus ^{at Baker's St.} 3d "

It will be seen that I have divided up ^{the route} into mile sections at 1d per mile, and have adopted a through fare of 2d to Bell Street, a distance of approximately 3 miles and a quarter, and a through fare of 3d to the terminus at Baker Street, a distance of 4 miles and a quarter.

In the above I have disregarded the proposed extension into the City of Melbourne, as the construction of the portion has not yet been decided on, should this extension be constructed I consider that the following schedule of fares should be adopted.

- 1. Queensberry Street to ^{Queen} Princes Street, 1d Section.
- 2. Princes Street to ^{Park St.} Brunswick Road, 1d "
- 3. ^{Park St.} Brunswick Road to Albion Street, 1d "

SYDNEY ROAD LINE.

- 4. Albion Street to Sydney Road, via Moreland Road. 1d "
- 5. Moreland Road to Bell Street, 1d "
- 6. Bell Street to terminus at Baker's Road. 1d "

& alternatively £3300 for only 150' to Moreland Road by a depth of 350' along Wickham Street

Resolved that the letter be received and an offer of £975 made for the smaller area of 120' x 350'.

Resolved that Mr. Beatherston be asked to submit a price at which he will transfer land on east side of Wickham Street.

The accounts as per list were passed for payment and also for transfer of the accounts to the Commercial Bank.

Consideration of the purchase of fodder for future delivery was referred to the Chairman and C. Campbell with power to act.

A report by the Engineer and Manager relative to proposed sections was submitted and agreed to after slight amendments as per attached report as far as they apply to Brunswick and Coburg.

Resolved that the charge per horse per week for maintenance of three horses stable for the Council be 15/-.

Resolved that the remuneration for the cleaning of the Engineer's Office be 20/- per month and that the Council Hallkeeper be employed.
