SPECIFICATION

1. GENERAL:

This Specification covers the supply and delivery to the Board's Central Garage at Scotchmer Street, North Fitzroy, Victoria, of four (4) Sedan Type Motor Cars.

Each vehicle shall be complete with all gear, apparatus, fittings, tools, spare wheel and tire, spare parts catalogue, instruction book and drawings necessary for its satisfactory operation and maintenance.

Early delivery is important and Tenderers are required to state the time for delivery after acceptance of contract.

The term "approved" in this Specification shall mean "approved by the Engineer".

2. REQUIREMENTS:

Each vehicle shall be of the latest available model sedan type with four (4) doors, shall be powered with a six (6) cylinder engine within the R.A.C. Rating Range of 16 H.P. to 24 H.P., and shall comply in all respects with relevant provisions of the Victorian Motor Car Acts and Regulations.

3. BODY:

The body shall be of all steel construction, leather trimmed throughout and equipped with all necessary appointments for safety and comfort on long distance travelling, including interior light, trim sun visors, twin windscreen wipers and a rear vision mirror, a lock-up luggage compartment or boot of large capacity, with a "well" to contain the spare wheel and tire shall be provided.

The windscreen and all windows shall be glazed with approved safety glass.

The body colour shall be either beige or oyster grey.
