
The following dress standards have been established policy for a number of years and are re-issued to ensure that the Corporation's standard is maintained.

MINIMUM DRESS STANDARDS

	FEMALE STAFF
SUMMER	Corporation issued Dresses or Corporation issued Skirts and Shirts - Jumper and Jacket as required. (jumper with union logo may be substituted for Corporation issued jumper). Approved Shoes - BLACK and must be CLEAN Hats/Caps (optional) - Corporation issue. Stockings - Natural Colour, (fawn). Multi coloured stockings or socks are not permitted.
WINTER	Corporation issued Skirts, Shirt, Jacket and tie. Jumper, Castro Jackets and Corporation issued Raincoats may be worn as required (jumper with Union Logo may be substituted for Corporation issued jumper).
	Skirts may be substituted with slacks. Approved Shoes - BLACK and must be CLEAN. black boots may be worn with slacks.
	BLACK BOOTS or ankle length boots are not permitted when wearing skirts. Hats/Caps - Corporation issue.
	UNIFORMS MUST BE CLEAN AND IN GOOD REPAIR AT ALL TIMES.

APPEARANCE

Must be clean and combed.

Excessive hair styles are not advised.

BADGES

As per Rule 18

"Drivers and Conductors, whilst in uniform, are not permitted to wear any Emblem, except a Returned Serviceman's Badge or Decoration, a St. John's Ambulance First-Aid Badge (if qualified to wear it) "Service Now" badge and the badge of the Australian Tramway and Motor Omnibus Employees Association, which if worn, must be worn on the coat lapel."

	Long Green Socks - MUST be worn with Shorts.
	Approved Shoes - BLACK and must be CLEAN.
	Hats/Caps (optional) - Corporation issue.
WINTER	Corporation issued Shirt, Tie, Jacket and/or Jumper. Trousers. Overcoat, Castro Jacket and Rain-coat may be worn as required. (jumper with union logo may be substituted for Corporation issued jumper).
	Approved Shoes - BLACK and must be CLEAN.
	Approved BLACK BOOTS are permitted and must be CLEAN.
	Hats/Caps - Corporation issue.
	UNIFORMS MUST BE CLEAN AND IN GOOD REPAIR AT ALL TIMES.

APPEARANCE
